

Bettie joined the U.S. state department after her honorable discharge and college. She met her husband William in Karachi, Pakistan, where they married at the U.S. Embassy. Her husband passed in 1992.

The couple settled in Arizona in 1962. They raised four children who then gave them a total of six grand-children as life went on.


If you couldn't find Bettie, better check the golf course. Bettie LOVED golf. She taught many old and new golfers at the Arizona Golf Resort and the Cumberland Golf Club, WI, swing tips, impromptu lessons, rules, and etiquette. As an early advocate for women's golf, Bettie help-ed organize the Arizona Silver Belle Championship and was a long time board member of

the Women's Trans National Golf Association.

Bettie loved being a Marine. Serving her country was extremely important to her. She carried on that service in WMA throughout her life, traveling to conventions and building lifelong friendships.

She was a founding member of her AZ-1 chapter, Arizona Roadrunners, serving as chapter secretary for many years and into her 90s.

In 2000, Bettie was elected to the national board of WMA as National Secretary. After her term ended, she

# **Colonel Julia Hamblet Award**

The Colonel Hamblet Award for 2020 is MSgt Laura Dennis USMCR (Ret). The award will be presented at

the 2020 celebration Award Dinner celebration of Excellence on 24 October at the Marine Corps Heritage Foundation, Quantico.

MSgt Dennis retired from the Marine Corps and for a period of 10 months, January through October 1946, did "grunt" work as a Marine volunteer researching our history for the book "The History of Wom-



en Marines 1946-1977" written by Col Mary Stremlow, USMCR, for the History Division, HQMC. MSgt Dennis passed away on January 26,2008, making this a post-humous award.

The Colonel Julia E. Hamblet Award is funded by a

bequest from the estate of Lotus Mort and judged by the Women Marines Association. It is given to the individual or team who has done the most to further the recognition of the history of women who have earned the



title Marine. Col Hamblet was the longest serving Director of Women Marines, having served in that position twice. The colonel was with us until her passing in 2017 at the age of 100.

# Reporting In... National President

#### <u>The Way Forward - Honoring our Legacy,</u> <u>Striving for Excellence into the Future</u>

As we enter the summer months and continue to face the challenges of battling the effects of the COVID 19 pandemic, I hope this finds everyone safe and well. We are all learning how to deal with a new "normal" in our lives. Many new changes are in our future not only in our personal lives, but also within WMA.

Even though we had to cancel convention, the business of WMA must go on. The Board of Directors (BOD) has continued to work on your behalf to ensure WMA has a bright new future. Results of the coordination efforts with the special Working Group set up last fall to examine best courses of action to ensure our Association's future, we have taken the following steps:

- Partnered/Hired a new contractor/Association Management Company (AMC) and a design firm with the goals to:
  - \* Modernize (streamline structure, professionalize administrative processes/ fundraising, update brand image, tell the story better, evolve the membership model and drive new member growth with an innovative recruiting pipeline)
  - Redesign our website and membership database
- Appointed a streamlined Interim Board to govern WMA during a transition period with our new AMC
  - The Interim Board includes our current eight (8) Officers (President, Immediate Past President (IPP), 1VP, 2VP, 3VP, Secretary, Treasurer and Membership Secretary.
    - \* The five Area Directors that volunteered to remain in office (AD2, AD3, AD8, AD9 and AD10) will continue to serve in their respective positions.
    - \* The incoming 1VP will represent all Area Directors on the Interim Board to include those five Areas without serving Directors.
      - She will also be the main representative voice for all Chapters and Members at Large (MAL's)
  - The Interim Board will serve from September (original date of convention and end of the term of office of the current Board) through elections for a newly defined "Governing Board".
  - The Interim Board will work with the new AMC to help define what a new "Governing Board" structure would look like in the future and then present to the membership for a follow on nomination and election

process for these newly defined positions.

A special thanks to our outgoing BOD members for all of their dedicated support over the past two years: Angela Maness (1VP), Jamie DePaola



(AD1), Joanne Molina (AD4), Julia Lee (AD5) and Jenifer (Nothelfer) Matheson (AD7).

I would also like to thank the National Officers who will serve on the Interim Board: Betty Moseley Brown (IPP), Rosa Osborn (1VP), Jeannine Franz (2VP), Pat Lewis (3VP) Mary Ellen Stone (Secretary) Peggy Reiber (Treasurer) and Jennifer Homan (Membership Secretary). The Area Directors who will continue to serve in their respective positions include Jo Ellen Schumacher (AD2), Patricia Collins (AD3), Patricia Horton (AD8), Jacqueline Caputi (AD9) and Soledad Kennedy (AD10).

As your National President, I feel privileged to stand beside this professional group of volunteers, as we focus our responsibility to lead WMA through a successful transition to a new and improved WMA as we "honor our legacy and strive for excellence into the future."

#### <u>WMA - Working Group - Summary of Progress</u> As of June 20, 2020

In the fall of 2019, WMA convened a Working Group to examine best courses of action to ensure the organization's future. After an open nomination and screening process, eleven women, and facilitator Courtney Lynch from Lead Star, were selected to serve on the Working Group. Members were selected based on their interest, ability to contribute, and a desire to assemble a group with diverse experiences and perspectives on WMA. The Working Group immediately began convening and connecting to clarify the scope of the group's engagement. The group determined that its purpose would be to examine the present state of WMA and explore and recommend pathways forward that support future success for the organization.

All Working Group members participated in a January 2020 retreat. During the retreat, the group focused on understanding and articulating current challenges and developing strategic priorities for the way forward. Challenges noted for resolution included:

- The need to evolve towards a culture of excellence that is relevant, inclusive, and purpose-driven
- Develop a compelling value proposition (Answering: Why join? Why contribute? Why engage?)
- ♦ Improve the current member experience
- Modernize (streamline structure, professionalize administrative processes/fundraising, update brand image, tell the story better, evolve the membership model and drive new member growth with an innovative recruiting pipeline)
- Funding the future

In response to these challenges, the group developed a working draft of a three-year strategy, entitled, "Honoring the Past, Excellence for the Future." The strategy articulated this vivid vision for success:

We desire to transform the Women Marines Association so that it becomes the thriving membership organization of choice for female Marines (past, present, and future) looking for camaraderie, mentoring, support, and the opportunity to continue to have a positive impact.

We will.

- Foster a culture of inclusivity, connection, diversity and belonging
- Understand, preserve, and share the history of women Marines
- Provide our Members opportunities to grow, develop and serve together
- Become recognized, respected, and relevant so women Marines are eager to engage and join and the private sector is aware of our brand and impact

It also provided specific outcomes and goals to quantify success:

We will achieve excellence by:

- Designing the organization and member experience to be stronger and better fit for impact
- Modernizing, and improving awareness by living and telling our story in more relevant ways
- ♦ *Professionalizing and elevating our operations*
- Raising funds to grow, evolve and sustain excellence and contribution

These strategic actions will contribute to WMA becoming the organization of choice for women Marines, and an organization of impact and value for our country.

Based on the review of current challenges and the emerging strategic priorities, the Working Group realized that it was time for WMA to partner with a professional association management company (AMC) to ensure access to the expertise, best practices and processes necessary to achieve its vision.

The Working Group, via a subcommittee, screened approximately 140 AMC's, narrowing the selection multiple times for heightened levels of follow up by the full group. Ultimately, the Working Group received proposals from four finalist management firms. After an interview and briefing process, the Working Group has selected Virtual, a full service association management company as the best fit partner for WMA moving forward. Multiple debrief sessions and surveys were conducted to ensure all feedback was received, debated, and discussed thoroughly in order to make a confident recommendation to the Board as to the best AMC for partnership.

 In addition to selecting an AMC partner, the Working Group also evaluated the option of engaging a design firm to lead WMA through a rebranding process. This extra layer of support was reviewed due to the strong need for WMA to transform how it engages both with members and external audiences (prospective members, donors, and communities) in telling its story and sharing the value it brings to members and society. It will be critical for WMA to elevate its brand image, storytelling, and stakeholder engagement to achieve fu ture success.

The Working Group will likely dissolve into action committees focused on:

- ♦ Onboarding Virtual, the AMC partner, effectively
- ♦ Rebranding and better telling the WMA story
- ♦ Improving the WMA member experience

#### **BIG CHANGES AHEAD**

As you can read in the President's message in this issue, the WMA National Board of Directors has approved a pathway ahead for the future of WMA. Your Board set up a Working Group (WG) to make recommendations



for the future. With the help of Courtney Lynch, female Marine and co-founder of LeadStar, the WG researched and recommended, and the Board approved, the hiring of a design company and an Association Management Company (AMC). This will help us become a more streamlined organization and take the load off our volunteers; the AMC would take over the "administrivia," freeing up our volunteers while making membership in WMA a more meaningful experience for all. The design company will help us tell our great story in a way that will make a difference to future members and donors. This will, of course, cost money. We do have funds to cover this, but we'll be eating into our "seed corn." The AMC will assist in fund raising, but we won't see much return on our investment for at least a year and maybe two.

Unfortunately, we had to cancel our national Convention and Professional Development Conference in Omaha this year. I'm asking you to think about the money you would have spent on transportation, food, lodging, and incidentals to attend the convention and consider using the enclosed envelope to donate that amount, or whatever you're comfortable with, to WMA to help us move forward into an exciting future. If you were not planning on attending convention, please consider a donation anyway. The first 200 donors of \$200 or more will receive the Omaha 60th anniversary coin and a special certificate recognizing the donor as a part of "Honoring the Past, Evolving into the Future." The first donors who send in \$60 (but less than \$200) will also get something special. All donors of funds, regardless of amount and if received by 10 November 2020, will receive the special certificate.

And of course, if the pandemic affected you, your family and/or your livelihood, we'll understand you can't contribute right now. Know that our thoughts are with you and that WMA grants may be able to help you. Check your Resource Manual and Directory page 19 for

how to apply. And you can still be a part of this exciting future by contributing your thoughts and ideas. You will likely receive a survey on this topic – please take a few minutes to answer it. If you don't see the survey, please provide your thoughts and ideas by the  $10^{\rm th}$  of November 2020 to policy@womenmarines.org or to the mailing address on the envelope enclosed. We can use positive suggestions on what to do to update the organization and keep us relevant, improving, and growing.

Sincere thanks to the WG and all that's been done so far as well as to the Past National Presidents and the Board for recognizing the need for and supporting this major change for WMA. More to follow...

Besides being a longtime member of CA-3, Barbara was also the Historian of CA-3 for several years. At the Biennial Conventions, Barbara won the coveted first place banner for her work on the CA-3 History Book on more than one occasion. #### **Life Member Perishes on Historic Trip**

Angela Madsen was living a dream. The three-time Paralympian, Marine veteran, and life member of WMA (CA-5) since 2015, was rowing 2,500 miles across the Pacific Ocean to Hawaii. She was trying to become the first paraplegic, first openly gay athlete, and oldest woman (60) to tackle the trip. ALONE.

Unfortunately, after not hearing from her for 24 hours, a German cargo ship found her floating in the water, tethered to her boat, RowofLife. She reported earlier that she had to get in the water to fix her anchor because a storm was coming. And that's the last time anyone heard from her. She had made it halfway to Hawaii. Had she made it, it would have taken her four months.

Angela enlisted in the Marine Corps in 1979 and became an MP at El Toro. She also played center on the All-Marine women's basketball team. During one game in 1980, someone tripped her and someone else landed feet first on her lower back. Two of her discs ruptured in her lumbar spine, ending her Marine Corps career. Then, a botched surgery in 1993 paralyzed her from the waist down.

The military refused to pay her medical bills. This left her homeless. She ended up living on the streets and then out of

a storage locker at Disneyland.

Her life turned around when she discovered adaptive sports after a rehabilitation program at the VA Long Beach Healthcare System.

She started rowing in 1997 and was so motivated that she started an adaptive rowing program.

She earned spots on the U.S. Paralym-

pic teams in 2008 as a rower, 2012 and 2016 as a track and

field athlete. She won the bronze medal in shot put at London in 2012.

Angela has the distinction of being the only person in the world to complete four ocean rowing crossings of three oceans, and to have rowed a circumnavigation of Great Britain, and laid claim to 14 Guinness World Record titles in



rowing. She is also the only paraplegic to surf in the women's world championships of longboard surfing in Biarritz, France, making the 2015 US ISA adaptive surf team.

Before her passing, Angela founded and ran a non-profit adaptive rowing program in Long Beach, the California Adaptive Rowing Program. In 2013 she released a book called "Rowing Against the Wind" and is a 20 year board member of the California Paralyzed Veterans. She leaves behind her wife Deb, and five grandchildren.

"I do know that whatever my purpose is in this life, my dif-



ferently-abled, physically-challenged, broken-down, beaten-up body seems to be the vehicle required for me to achieve it... I am purpose driven; I may suffer pain and not walk upright in this life, but when I go home, I will not suffer the walk through the gate. I can live with that. If I could go back and change things, I would not. It would be nice not to have to suffer so much pain but, hey, that's just the way it is... In the beginning, I was angry. But now, I completely understand." ~ excerpt from Angela's memoir, "Rowing Against the Wind"



#### **Treasurer**

The year started off in a flurry of change. The administration Contractor resigned, and WMA hired OrgSpt to handle the various administrative and financial needs of the organization.

The attempt to use the outdated 166 line chart of accounts and the older version of QuickBooks led to the need

to open an entirely new set of books while maintaining the outdated format for historical use.

The new chart of account is in accordance with Generally Accepted Accounting Procedures (GAAP). It is arranged in 10 classes to allow the Board of Directors (BOD) the ability to view the overall financial income and expenditures of the organization, instead of the individual 18 Board members expenses at general items and separately their board expenses.

During this period, the Financial Advisory Committee (FAC) has agreed that there will be a set scholarship amount of \$50K; vice the uncertainty of basing each year's expenditures on investment interest. This allows the scholarship committee to act on the submissions quickly and with accuracy.

The changeover of the membership database, and the lack of corresponding website sharing, led to the creation of a new database, and additional costs in trying to update the website. This lack of accurate numbers of term, life, and deceased members has led to a delay to account for the amount of funds to be moved for the various categories. The CFRB report is in limbo awaiting these membership numbers

As an outcome of the Interim Board Meeting held in Omaha in Aug 2019, a special project Working Group (WG) independent of the board was established and funds in the amount of \$35K were allocated.

The WG has been exploring the possibility of moving from an admin contractor to an actual Association Management Company (AMC). As treasurer I have been involved in the Zoom meetings with various possible companies.

With the pandemic causing the cancellation of the 2020 Convention in Omaha, this will have an effect on the upcoming budget year.

So, as we move into 2020-2021, the Working Group will determine a Board of Directors reorganization to submit for approval of elected officials. The usual elections have been delayed for the restructure to take form.

Change is continuing to allow growth and future potential.

The plans for the old building will be to refurbish it and turn it into a museum of some sort. Various organizations will have offices within the building, including WMA. I would like to display our memorabilia and some of the older uniforms. There is no date for this to be accomplished.

#### **Headquarters National Property**

- Purchased new artificial roses and babies breathe to place in the WWI boots displayed at convention. There are 22 roses, 11 in each boot. These roses are a memorial to the 22 WWI ladies that were original members when WMA was founded in 1960.
- ◆ The Broe Award was damaged at the corners by either being dropped or damaged in shipping. Metal corners were applied to the corners to protect the plaque.
- The protective felt sleeve has a hole where the corner came through. The hole is too small to repair, so I left it alone.
- ♦ Three of the four plaques, History Book, Newsletter, and Broe, will need to be replaced after the next two conventions as the name-plates will all be used. The Website award still has 6 name plates remaining. Plaques are donated by various donors.
- Headquarters is storing the original first set of plaques. This group is the second set to accommodate recent awardees. The original plaques are much larger and much heavier than these. If and when the White House is converted into a museum, our older plaques can be displayed.

#### **Matching Funds and Grants Committee**

- ◆ On 2/5/2020, Patti Orsini (NC-1) assumed the duties as Chairperson from Catherine Barker (NC-3).
- ♦ Reviewed and approved 1 Matching Fund request for NC -3 for \$250, per MFG guidelines. The annual budget is \$1000 and there is \$750 remaining in the FY20 budget.
- At the time of turnover, the Emergency Grant account had a balance of \$9500 comprised of the annual allocation of \$6000 and a balance of \$3500 carried forward from FY19. Of the 7 applications received, 5 were approved.

- Recipients were all women, 4 USMC, 1 USA
- All were unemployed, in receipt of VA disability, and had financial difficulties due to illness, loss of employment, or COVID-19 layoff.


