### Mary Knapp

By now you are all aware that we lost one of our Past National Presidents, Mary Graham Knapp.

Mary was 87 years young when she passed away on 29 March. For the past two years she resided at the Beehive Assisted Living Home in Pahrump, where she could be near her daughter, Libbie.

Mary came to us via Arno, TN. She was a beautician who worked her way through college. After graduation from Middle Tennessee State University in Murfreesboro, she joined the Women's Reserve. She got her graduate degree from Peabody Teacher's College in Nashville.

Mary was married to Ed Knapp for 29 years. She remained in the reserves until 1956, when she was relieved of her duties as a captain. Until her recent illness, Mary was an active member of University United Methodist Church. She was a trustee, member of Rebecca Circle, literacy teacher, and was known for her famous pecan pies. Mary taught at Las Vegas High and later at Rancho High, until she retired in 1979. Her specialty was home economics.

Mary became a volunteer and spent many hours in the Veteran's Clinic in Las Vegas, as well as at the Salvation Army. She traveled extensively all over the world, including China which was her favorite of all her adventures. Mary leaves only one daughter, Sarah Elizabeth (Steven) Hamrick; and two granddaughters, Mary Beth and Katie, all of Pahrump.

So said Mary's obituary. Since we are all so much more than an obituary, the below is taken from the eulogy given at her service by her dear friend, Joyce Hartley.

"I've known Mary Graham Knapp since 1974 and I guess fate ordained that we would become friends and ultimately working partners in the ensuing years.

Mary never forgot my phone number, almost to the day of death. She might not remember her last meal but she knew my number. One time she had fallen and had to crawl to the phone and I do believe she did call 911 but then called me and thank goodness I was around to help.

On 13 February 1943 when the Marine Corps Women's Reserve was established, Mary was one of the thousands of eager young women from across the country that flocked to the recruiting stations to enlist in the WRs. She was the first woman from middle Tennessee who was accepted into Officer Candidate School, from which she graduated in April. She was sent to Quantico and was mess officer in one of the main mess halls on that base. And you better believe the rank and file of Marines probably didn't miss a meal because she would have made sure the food rated an A+.

Mary met Edward Knapp in 1942 and married him in 1946. She met him when he was on maneuvers in Tennessee and their fates were sealed. By the way, he was Army; we did not hold that against him.

Mary was discharged in 1945 and she and Eddie eventually came to Las Vegas to be married. After another few years in Tennessee they decided to move to Las Vegas to spend the rest of their lives together and where they both taught school.

To keep alive the camaraderie and esprit-de-corps of the Marines, several women Marines established the WMA in Denver in 1960. But it was not

until 1973 that Las Vegas organized a chapter. Mary was a charter member and at that time had no clue how her life would soon revolve around the Nevada Sagebrush Chapter and to what heights it would bring her. She was a school teacher and a busy mother so her life was already quite full, but following the death of her beloved husband in 1975, she started becoming more and more involved in Marine activities. She volunteered at the VA Clinic where in May 2001 she attended the VA's volunteer recognition banquet and received a certificate for 3526 hours and 19 years of service. She probably did continue for another year or so. She belonged to the Greater Nevada detachment of the Marine Corps League, the Leatherneck Club and the American Legion. She held countless offices in countless organizations. Marching in the Veterans' Day Parade in her WR uniform was a must every year. When she could no longer march, she managed other ways such as on a motorcycle.

She also gave blood regularly and who knows how many gallons helped those in need. (Continued on page 4)

### **Another First**

We have another "first" to add to our long history...the first female commanding officer of Camp Lejeune.

This honor goes to Col Adele Hodges, a native of Bridgeport, CT and graduate of Southern Connecticut State College who enlisted in the Marine Corps in June 1978. She was accepted into the Enlisted Commissioning Program and was commissioned in December 1980.

Her list of tours is long. For space and time sake, she served at: 3rd Supply Battalion, 3rd FSSG in Okinawa, Japan; Marine Forces Pacific Headquarters (formally FMFPac) in

Hawaii; 4th Marine Aircraft Wing (MAW) in New Orleans; Headquarters Battalion, 2nd Marine Division; Desert Storm; Marine Corps Air Ground Combat Center; U.S. Army Command and General Staff College (CGSC) in Fort Leavenworth, KS; Marine Corps Combat Development Command in Quantico; 1st Maintenance Battalion, 1st FSSG; 1st Force Service Support Group (FSSG) in Camp Pendleton; Brigade Service Support One during their preparations and deployment for Operation Natural Fire 2000 in Kenya; Naval Station Newport to attend the U.S. Naval War College; NATO Joint Headquarters North in Stavanger, Norway, which transformed into the NATO Joint Warfare Center which transformed into Chief, Joint Training Division, of the Joint Warfare Centre, the largest Division in the Centre.

Whew! Colonel Hodges has Masters Degrees in Business Administration, Military Art and Science, and Strategic Military Studies. She has been awarded the Meritorious Service Medal, Navy Commendation Medal with 3 stars, and a Navy Achievement Medal.

### Marine and Family Services Relocating to New Home

Building 1 has served as a home to various offices at Henderson Hall since the early 1940's and this summer it will no longer be a part of the base. The building, which houses Marine and Family Services, will be demolished and the offices within the division will move to the trailers that are being built beside Bldg. 28.

Bldg. 1 was initially constructed in 1945 and as an H-shaped building which, within two years, was extended to have a second story. After reviewing the blueprints, Marshall could tell that Bldg. 1 housed an infirmary and the administration offices up until 1960.

"Bldg. 1 is approximately 65 years old," said Facilities Director Geoffrey Marshall. "It has gone beyond its lifespan, without having to invest a lot of money into the building. It's just in poor shape."

"By 1960, the infirmary was gone and it housed a number of departments including personnel, the Provost Marshal's Office (PMO), Battalion Legal, a mailroom, the fiscal department, S-4 and the command offices," said Marshall.

Marshall also gathered that from 1960 until 1993 the configuration stayed the same. Once Bldg. 29 was built (the present headquarters building), PMO and Battalion Legal moved in. By March 2003, the other departments moved out of Bldg. 1 and into Bldg. 29. Marine and Family Services then moved out of Bldg. 29 and into Bldg. 1, where it is currently located.

Before Bldg. 1 is demolished, it has to be approved by the National Capital Planning Commission and the State Historical Preservation office.

"We are looking, at the earliest, the first of July to begin the destruction of the building," said Marshall.

In May, Marine and Family Services will have to pack up and move into the trailers.

"We are excited," said Exceptional Family Member Coordinator and Information and Referral Specialist Carol LaVoy. "There are so many environmental factors in this building that we are really looking forward to the move."

LaVoy believes that, by moving, it will give her a chance to do some "spring cleaning" and weed out things that she no longer has a need for.

"It's bittersweet," said Janet Hammes Marine Corps Family Team Building Coordinator and Volunteer Coordinator. "It will be nice to be in a new area when we have clients come in. It's exciting!"

Marine and Family Services Staff NCO SSgt. Greg Ashby explained that the projected time for Marine and Family Services to remain in the trailers is tentatively 12 to 18 months. Bldg. 12, which currently houses the facilities department, is scheduled to be renovated this year and once complete, will be the new home for Marine and Family Services.

"We will miss the historic building, but it is time to move on," said Hammes.

When asked by Robert Mayhew, Nevada Commissioner of VA Affairs, Mary spearheaded a drive to organize an all-women veterans group or get together for Women Veterans Week in 1985. This was done very successfully and went on to become the Women Veterans of Nevada and still continues today. She was always active in that group as well.

Mary was also active in her church for many years and never failed to contribute her service wherever and whenever needed. And could she bake a cherry pie? Oh yes, and apple, and peach but most especially dozens of pecan pies for church fund raising.

Those pies were also present many times for our chapter projects and events. Her home was known in WMA circles as Hotel Knapp. Anyone - Marines and friends - from anywhere in the country was invited to stay. And they did, even sometimes when she was not going to be in town. She had faith in her fellow Marines.

Her home was the site of our WMA Christmas parties. We tried to count them up one year and decided on at least 20 years, plus other events such as ice cream socials, yard sales, special luncheons or just a meeting. Mary would never turn you down if you asked for help and many charities besides the ones I have mentioned benefited from her love for doing

for others.

Mary's abilities soon caught the attention of the national officers of WMA and soon she had accepted a small position on the national board as 1st vice president and then national president with me as her national secretary. We served two two-year terms, 1980-1984, and that was a ride, but Mary was so proud of being a Marine, of being in WMA, that nothing was too difficult.

In Denver in 1990 at the biennial convention, Mary was presented with the National Service Award, WMA's highest honor.

I shared many a trip with Mary going to conventions or other events all over the country, even a couple of cruises, and even going back to the bases where we had been stationed some 35 to 40 years ago. Mary did love to travel and missed

few opportunities to do so.

In 1994 our chapter held a convention in Las Vegas. This was done in 1998 and our roles were reversed - I was convention chairman and she was my secretary. This amounted to four years of non-stop work for all of us in the chapter and the results were a credit to our membership, and in some circles it was said to be the best WMA convention ever. And there have been many since that first meeting in Denver. Ours was the 20th Biennial Convention.

The last few years have not been kind to Mary and a lesser woman would have given up long ago. But she fought back always until this last broken bone proved her last fight.

When Mary enters those pearly gates it will be to a rousing welcome from a multitude of Marines, from the highest brass to the lowliest private, those she knew and didn't know, and she will be home. She will soon be pounding that gavel and bringing order where it is needed.

We salute you Mary, and I'm waiting for one of those unexpected phone calls. I want the scoop on how things are up there.

We will miss you. Semper Fidelis, Mary."

### Heritage Foundation Dinner

The First Colonel Julia Hamblet Award was presented on 31 March at the Marine Corps Heritage Foundation Awards Dinner, held at the Sheraton Premiere Hotel in McLean, VA. The first recipient was Brigadier General Margaret Brewer,

USMC, (Retired).

The Hamblet Award goes to the individual who has best promoted "the preservation and history of women Marines". This award is funded by the Lotus Mort Fund of the Women Marines Association and administered by the Heritage Foundation. There were five nominees for this first annual award.

Members of the place Women Marines Association appeared en masse, as approximately thirty WMA members plus their guests attended the black tie dinner. The purpose of this annual event is to present awards to those who have done the most to preserve the traditions and history of the Marine Corps.

DC-1's very own Margaret Brewer, who served as the last Director of Women Marines from 1973 through 1977, was recognized for her contributions to the Corps while serving as the last Director of Women Marines and as the first woman Marine flag officer; for her contributions to WMA in their endeavors to promote growth and development within the organization through participation in

the Short and Long Term Program of WMA; Chairman of the Marine Corps Council and other positions within our association; the Heritage Foundation during all phases of the plans for the museum, which will open on 10 November

2006.

At the dinner, General Brewer was seated next to the icon for whom the award was named, former of Director Women Marines from 1946 to 1948 and 1953 to 1959, retired Col Julia Hamblet. Another woman Marine award recipient was SSgt Karen Summers of the Marine Corps Band, who shared her award with SSgt Gregg Travis for their

The festive event was emceed by Actor Wilford Brimley (a former Marine), and the Military Guest of Honor was General Peter Pace, USMC, who is Chairman of the Joint Chiefs of Staff (also a first for the Marine Corps); Senators John Warner and Ted Stevens, and other notables too numerous to mention.

To date over 2,000 school children have toured the museum. Museum visitor counts are much higher than normal. We have done one re-display to keep visitors coming back. The Marine Corps Flag flies 24 hours a day and can be seen

from Interstate 25. Both Paula Sarlls and I take turns being at the museum and keeping the display fresh and clean. The exhibit runs through August 2006.

### Navy League Recognizes Women

The San Diego Council Navy League hosted the 2005 Naval Services Enlisted Women of the Year awards March 29 at the Admiral Baker Clubhouse in San Diego.

The event featured women in the Marine Corps, Navy and Coast Guard whose parent command is located in San Diego County.

There were a total of 35 women nominated for the awards, 13 of whom are with 3rd Marine Aircraft Wing.



Each nominee was required to write a one page essay themed, "What being in the military means to me." The league chose two winners based on the best essays.

The award winners were 3rd MAW Petty Officer 2nd Class Melissa D. Cornell, Marine Aircraft Group 39, and Petty Officer 1st Class Mickenszie J. Pearson, Marine Wing Support Squadron 374, Marine Wing Support Group 37.

Both winners were awarded a \$1,600 scholarship from National University in La Jolla, Calif., among other prizes provided by various corporate sponsors.

"It is one thing to identify individuals and their achievements, but it is even better when they can be presented with tangible items as well," said MajGen-Select John M. Paxton, commanding general, Marine Corps Recruit Depot San Diego. "We are very appreciative of the Navy League and the corporate sponsors for putting on this event."

The reason for me doing so is because we want to invite any woman Marine who ever served with or in the Second Marine Division to join us. We are about seven thousand strong, and it just occurred to me that there was a whole segment of Marines that have never been tapped to help the SMDA get even stronger in its stated goals: to help in any way that we can the young warriors going in harm's way.

Among our activities are scholarships for kids of Marines serving or who have served in the Second Marine Division. Every year, we give out tens of thousands of dollars in scholarships. We also have something called "The Wounded Warriors Fund," which is dedicated to helping those heroes returning home wounded.

Normally, if they served in Iraq or anyplace with the Second, and were wounded, they are returned to the home of the Second, Camp Lejeune, to the hospital there, and then into the Wounded Warriors Barracks where they undergo any rehabilitation needed to get them as back to normal as possible. We help by donating equipment and such to the hospital, or in getting the families of wounded Marines who cannot afford the expense to come to Camp Lejeune, taking care of the airline tickets and hotel accommodations near their Marines for at least a few days.

But, beyond that, we are a social organization. We have regional reunions and the national reunion every year. This coming September, we will be getting together in San Diego. Next year, we will be in Washington, DC. The expense to join is very reasonable, and every cent we garner goes towards helping our young Marines. Another highlight of the year is in January, when we all go back to Camp Lejeune for a few days to award heroes with plaques and such, to spend a day in the field with

them, to actually get to use today's weapons. And there are evenings where we spend time with the enlisted Marines, and then there is the banquet at the Officer's Club.

### **Marine Finally Receives Purple Heart**

If it hadn't been for Marg Nyhagen, Cpl Federico Diaz-Martinez might never have been awarded the Purple Heart medal.

A Marine veteran who served in communications in Hawaii in 1958, Nyhagen became acquainted with Diaz-Martinez and his family after reading a story in the Walla Walla, WA, paper.

The story and a photo of Diaz–Martinez's face streaked with blood had been in the New York Times in March 2003 and on the cover of Time in April 2003. The picture was taken by a French photographer as Diaz-Martinez and his platoon commander were walking out of a hospital the platoon had just captured in Nasiriyah, Iraq. The face wound came from an exploding grenade that also hurt four other Marines, but none was badly injured. This came hear the end of Diaz-Martinez's four-year tour of duty, four months of which he spent in the Mideast.

When Nyhagen learned Diaz-Martinez

had received a letter of commendation for his service, but had not received the Purple Heart and also that the medal was held up because some paperwork got lost, she said, "Well then, we need to get to work on this."

Nyhagen contacted a friend, retired Rear Adm Darold Bigger, U.S. Navy Chaplain, and the local Veterans of Foreign Wars, which she was instrumental in organizing a few years ago. With their assistance, finally Diaz-Martinez was presented the Purple Heart in a ceremony held recently at the Johnathon M. Wainwright Memorial Veterans Medical Center in Walla Walla. Admiral Bigger, who wore his Marine uniform for this occasion as he had been a chaplain for the Marines as well as the Navy, pinned the Purple Heart medal on Diaz-Martinez.

Diaz-Martinez, wearing his Marine Corps dress blues, thanked Adm Bigger saying, "I'm honored that you pinned this

medal on me. And I thank all of you for coming to this ceremony and a lot of thanks to Marge Nyhagen." Nyhagen thanked the crowd for coming, "because he is your hometown hero." A reception followed.

The affair was attended by Diaz-Martinez's family, a host of friends, the media, Washington Rep. Cathy McMorris and Virginia Allred. She and Nyhagen are both life members of WMA and are members of the Eastern Washington State chapter.

VA's legal counsel has requested we inform our installations, particularly mobilization sites of this group and their lack of affiliation or endorsement by VA to provide any services.

# Project Identify and Recognize

Two national organizations that represent home economics professionals have initiated a program to identify those women in its ranks who are veterans of military service or are currently serving in the U.S. military.

The program entitled "PROJECT IDENTIFY AND RECOGNIZE", is being undertaken by the American Association of Family and Consumer Sciences (formerly AHEA) and the International Federation for Home Economics-U.S in preparation for their "100th Anniversary celebration in 2008/2009.

Home economics professionals are being asked to submit information about themselves or family members who have military service, past and present, to Janett Gibbs, project director.

"We're talking about a large group of professionals whose military accomplishments and contributions have been largely undocumented," said Gibbs. "Our plan is to identify them and give them the recognition which they rightly deserve."

The U.S. Department of Veterans Affairs has estimated that there are mere than 1.2 million women veterans. Another 200,000 women currently serve in the five major branches of the military. Exactly how many have been trained in home economics and related fields of study is presently unknown.

### Molly Marine Killed in Iraq

We lost a third female warrior in Iraq...24-yr-old LCpl Juana Navarro Arellano, 24, of Ceres, CA, died on 8 April from a gunshot wound to the head while supporting combat operations in Al Anbar province, Iraq. She was assigned to 9th Engineer Support Battalion, 3rd Marine Logistics Group, III Marine Expeditionary Force, Okinawa, Japan.

LCpl Navarro was in a defensive position 300 meters behind her vehicle, guarding fuel trucks and fellow Marines, when she was struck by small arms fire.

She originally was stationed in Okinawa where she traveled with convoys or by herself to refuel military vehicles or provide camps with fuel supplies. Because of the need for her specialty as a bulk fuel specialist, Navarro was transferred to Iraq in February 2006 where she

was attached to the 7th Engineer Support Battalion, 1st Marine Logistics Group, when she died.

Navarro was born in the state of Michoacán, Mexico, and became a U.S. citizen at age 13 along with her twin sister. She graduated from Johansen High School in Modesto in 2000, where she

was active as a volunteer with PALS (Peer Assisted Learning program), a class where students work daily with special education students on academics and social skills. After high school, Navarro joined Job Corps in San Francisco. But seeing her twin brothers join the Marines inspired her to act on her desire to join.

In 2001, Navarro's mother became a partner in the Habitat for Humanity program in Ceres, and her daughter spent

days swinging a hammer. They moved in to their house after helping to build it. Habitat officials said the family had worked far more than their 500 required hours for the new home.

When Navarro graduated from boot camp in August 2005, her fellow recruits voted her Molly Marine. Among the thousands of recruits who go through training each year, Navarro stood out enough that news of her death struck her former commanders as "heartbreaking".

She was proud of her service and her Corps. She had a good heart and was never selfish. And now, she gave her life for it.

Navarro was the third female Marine killed in Iraq since the war began in 2003, according to the Pentagon. Of the 2,361 U.S. troops killed in Iraq, 52 have been women.

We mourn the loss of another female Marine, this time in an automobile accident in Beaufort.

LtCol Annette Jacobsen, deputy comptroller on Parris Island, died 4 April after her car was struck on the driver's side by a dump truck on Ribaut Road.

Originally from North Tonawanda, NY, the lieutenant colonel graduated

from Officer Basic School in 1981 and was transferred to MCRD San Diego after Financial Management School to serve as OIC of the travel section. She also met her husband, Col Kenneth Jacobsen (Ret).

Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the online website. The new web-based application was designed to provide better service on these requests by eliminating the records center's mailroom processing time.
