### **Another Marine Reporting, Sir**

Olga C. Bullock, charter member of the Women Marines Association since 1960, passed away on June 3, 2006. Olga's involvement in and dedication to the WMA spans decades. Although she was in the Marines only a few years, her pride in being a woman Marine lasted her entire life. She has served as area director (1962-64), public relations officer (1964-66), vice president (1966-68) and national president (1968-72), as well as chapter treasurer (1988-2005) and Veterans Affairs Voluntary Service (VAVS) Representative (1985-2005) for the San Diego chapter. These impressive dates and titles do not do justice to the hard work, passion, and time Olga put into helping build and create the WMA.

Olga C. Bullock nee Zoricic was born in St. Louis, MO, on January 28, 1918. She grew up with her mother, grandparents and uncles, who all emigrated from

Croatia. graduated from Bayless High School in 1935 and went on to various bookkeeping and secretarial jobs. On October 13, 1943 she enlistin the Marine Corps and arrived at Camp Lejeune on January 1, 1944. At boot camp, she made PFC and eventually received orders for Miramar in late March 1944 where she was assigned as a clerk-typist in supply. She made corporal before being reassigned to the Auditors Office in early March 1945 and was promoted to sergeant in September 1945. Olga was discharged at MCAS, El Toro on January 25, 1946.

After the war, Olga enrolled at UCLA as a business administration major but left school after getting married in the summer of

1946. She had three children: Maryjane (now deceased), James and George. In 1953, she went to work at NAS North Island after divorcing her husband. Olga worked in the North Island Supply Department for 24 years. She retired in 1978 as a G-7 supervisor of Overhaul and Repair Department.

In her retirement, Olga always kept busy—spending time with her family, traveling and volunteering. Olga was

actively involved with her two granddaughters Michelle and Heather (daughters of Maryjane) and often took them to the beach, the zoo, and the library. Olga was also a world traveler and visited every continent, including Antarctica. Not only has she traveled to places like Thailand, Kenya, and Austria, but she also traveled extensively throughout the United States through Elderhostel.

Olga's countless volunteer hours to various organizations also reflect her values and passion—the VA Hospital, Birch Aquarium, Walkabout International in Coronado, and the San Diego Museum of Art. She also was a member of the American Legion Post 451, Waves National, and of course, the WMA.

The last year of her life was difficult because she had to move from her beloved San Diego, where

she spent over sixty years, to live closer to her granddaughter Michelle in Oakland. The transition of lifestyle—from being so actively involved in WMA, volunteering, exercise class, to living in a new city, a new home (assisted living in Alameda), and new demands on her health—was difficult for such an independent, spirited lady. She did still manage to see some plays, go for walks, and do her best to adapt to her new life. (continued on page 4)

Also, a most important section...the bylaw and standing rule changes that will be voted on at the convention. Please become familiar with them.


Your officers and committee chairs have worked long hours on their individual reports. Those, too, are in this issue. Look them over so you can see how well they're doing volunteering their time for our association.

### Getting Authorization for Medals You Believe You Earned

Your DD-214\*, Report of Separation, lists your authorized medals\*\*.

If you know of a U.S. military medal you were authorized but is not listed on your DD-214 you should request a DD-215: "Correction to Form DD-214". (The DD-214 itself cannot be changed to correct, add or delete medal information.) In using Form SF-180 (see below) to request a DD-215 you MUST know the name of the medal(s) and possess or know of documentation in your Personnel File authorizing the medal(s).

If you know a medal you believe you are eligible for, but you were not authorized for reasons of discrimination, administration/transit glitch, denial, oversight, commander ignorance, etc., you must use Form DD-149 (see below) to apply for authorization. Form DD-149 requires you to provide evidence, names of relevant personnel, and a detailed reason why you were denied a medal(s) you feel you deserve.

Prior to submitting Form DD-149 you should thoroughly acquaint yourself with the official Issue Regulations [IR] for the medal(s). Do NOT submit a DD-149 if you have not fulfilled the criteria stated in a medal's IR.

IMPORTANT: Do NOT attempt to use Forms SF-180 or DD-149 for medal "fishing"... requesting a search to see if you might be eligible for more medals.

Col Navarre against three captains, three SNCOs, two NCOs and a



### Never Forget...

You're probably wondering why this artist's rendering of the Navy's latest amphibious assault ship, the USS New York, is in our newsletter. I thought



you might be interested in knowing that this ship is being built with 24 tons of scrap steel from the World Trade Center. The ship is about 45% complete and will be ready for launch in mid-2007. It will carry a crew of 360 sailors and 700 combat-ready Marines to be delivered ashore by helicopters and assault craft. The steel was melted down in a foundry in Louisiana to cast the ship's bow section. The ship will set sail with the motto "Never Forget".

### Two-Holiday Veterans vs Everyday Veterans

There are "Everyday" veterans... and there are "Two-Holiday" veterans.

"Everyday Veterans" remember their military service 365 days a year. "Two-Holiday veterans" remember their military service only when they read or see the increased number of news media reports about veterans and military service that routinely occur right before Memorial and Veterans' Day.

All veterans should become "Everyday Veterans".

- 1. Wear a military service or war ribbon on your collar every day.
- 2. You do not have to join a veteran's organization, but you should inform, by letter, all of your local veteran's organizations of your local residence.
- 3. Ensure that your DD-214 is updated with a DD-215 to reflect all of your medals, badges and awards. (Email The War Library if you need any advice on this.)
- 4. Make sure that you are listed in

The War Library's database... the largest, international on-line database of military service members, veterans and family members.

5. Find out the names of the military and veterans affairs reporters at your local newspaper and TV/radio stations and keep their list of names and contact info handy. Let them know they can contact you for any info they think you can help them with on a story they are working on. 6. Post a military-era photo of yourself in The War Library's database so that your confirmed veteran/military status can be confirmed by anyone...now and in the future.

### **CMC Hagee: On Marine Virtue**

Recent serious allegations concerning actions of Marines in combat have caused me concern. They should cause you to be concerned as well. To ensure we continue to live up to General Lejeune's description of a Marine as someone who demonstrates "all that is highest in military efficiency and soldierly virtue," I would like to review the importance of our core values.

As Marines, you are taught from

your earliest days in the Corps about our core values of honor, courage and commitment. These values are part of and belong to all Marines, regardless of MOS, grade, or gender. They guide us in all that we do; whether in combat, in garrison, or on leave or liberty.

To a Marine, honor is more than just honesty; it means having uncompromising per-

sonal integrity and being accountable for all actions. To most Marines, the most difficult part of courage is not the raw physical courage that we have seen so often on today's battlefield. It is rather the moral courage to do the "right thing" in the face of danger or pressure from other Marines. Finally, commitment is that focus on caring for one another and upholding the great ideals of our Corps and Country.

The nature of this war with its ruthless enemies, and its complex and dangerous battlefield will continue to challenge us in the commitment to our core values. We must be strong and help one another to measure up. The war will also test our commitment to our belief in the rule of law.

We have all been educated in the Law of Armed Conflict. We continue to reinforce that training, even when deployed to combat zones. We do not employ force just for the sake of employing force. We use lethal force only when justified, proportional and, most importantly, lawful. We follow

the laws and regulations, Geneva Convention and Rules of Engagement. This is the American way of war. We must regulate force and violence, we only damage property that must be damaged, and we protect the non-combatants we find on the battlefield.

When engaged in combat, particularly in the kind of counterinsurgency operations we're involved in now, we have to be doubly on guard. Many of our Marines have been involved in life or death combat or have witnessed the loss of their fellow Marines, and the effects of these events can be numbing. There is the risk of becoming indiffer-

ent to the loss of a human life, as well as bringing dishonor upon ourselves. Leaders of all grades need to reinforce continually that Marines care for one another and do what is right.

The large majority of Marines today perform magnificently on and off the battlefield. I am very proud of the bravery, dedication, honor, courage and commitment you clearly display every day. And America is proud as well. Americans, indeed most people around the world, recognize that Marines are

men and women of the highest caliber – physically, mentally, and morally.

Each one of you contributes in your own unique way to our important mission; I am proud of your dedication and accomplishments. Even after 38 years, I still stand with pride every time I hear the Marines Hymn. The words of that Hymn

mean something special to me. Especially, "Keep our Honor Clean". I know that means something to all of you as well. As Marines we have an obligation to past Marines, fellow Marines, future Marines and ourselves to do our very best to live up to these words.

As your Commandant, I charge all Marines to carry on our proud legacy by demonstrating our values in everything you do – on duty and off; in combat or in garrison. Semper Fidelis.



### **VA Data Theft**

In case you didn't get one, the below is a copy of the letter that was sent out by the VA to veterans whose data may have been included in the 26.5 million records that were stolen in May. The following page answers questions about what you can do to protect your identity.

#### Dear Veteran:

The Department of Veterans Affairs (VA) has recently learned that an employee took home electronic data from the VA, which he was not authorized to do and was in violation of established policies. The employee's home was burglarized and this data was stolen. The data contained identifying information including names, social security numbers, and dates of birth for up to 26.5 million veterans and some spouses, as well as some disability ratings. As a result of this incident, information identifiable with you was potentially exposed to others. It is important to note that the affected data did not include any of VA's electronic health records or any financial information.

Appropriate law enforcement agencies, including the FBI and the VA Inspector General's office, have launched full-scale investigations into this matter. Authorities believe it is unlikely the perpetrators targeted the items because of any knowledge of the data contents.

Out of an abundance of caution, however, VA is taking all possible steps to protect and inform our veterans. While you do not need to take any action unless you are aware of suspicious activity regarding your personal information, there are many steps you may take to protect against possible identity theft and we wanted you to be aware of these. Specific information is included in the enclosed question and answer sheet. For additional information, the VA has teamed up with the Federal Trade Commission and has a Web site (www.firstgov.gov) with information on this matter or you may call 1-800-FED-INFO (1-800-333-4636). The call center will operate from 8 a.m. to 9 p.m. (EOT), Monday-Saturday, as long as it is needed.

Beware of any phone calls, e-mails, and other communications from individuals claiming to be from VA or other official sources, asking for your personal information or verification of it. This is often referred to as information solicitation or "phishing." VA, other government agencies, and other legitimate organizations will not contact you to ask for or to confirm your personal information. If you receive such communications, they should be reported to VA at 1-800-FED-INFO (1-800-333-4636).

We apologize for any inconvenience or concern this situation may cause, but we at VA believe it is important for you to be fully informed of any potential risk resulting from this incident. Again, we want to reassure you we have no evidence that your protected data has been misused. We will keep you apprised of any further developments. The men and women of the VA take our obligation to honor and serve America's veterans very seriously and we are committed to ensuring that this never happens again.

In accordance with current policy, the Internal Revenue Service has agreed to forward this letter because we do not have current addresses for all affected individuals. The IRS has not disclosed your address or any other tax information to us

### **Answers to Frequently Asked Questions**

### I'm a veteran, how can I tell if my information was compromised?

At this point there is no evidence that any missing data has been used illegally. However, the Department of Veterans Affairs is asking all veterans to be extra vigilant and to carefully monitor bank statements, credit card statements and any statements relating to recent financial transactions. If you notice unusual or suspicious activity, you should report it immediately to the financial institution involved and contact the Federal Trade Commission for further guidance.

## What is the earliest date at which suspicious activity might have occurred due to this data breach?

The information was stolen from an employee of the Department of Veterans Affairs during the month of May, 2006. If the data has been misused or otherwise used to commit fraud or identity theft crimes, it is likely that veterans may notice suspicious activity during the month of May.

1 haven't noticed any suspicious activity in my financial statements, but what can I do to protect myself and prevent being victimized by credit card fraud or identity theft?

The Department of Veterans Affairs strongly recommends that veterans closely monitor their financial statements and visit the Department of Veterans Affairs special website on this, www.firstgov.gov or call 1-800-FED-INFO (1-800-333-4636).

## Should I reach out to my financial institutions or will the Department of Veterans Affairs do this for me?

The Department of Veterans Affairs does not believe that it is necessary to contact financial institutions or cancel credit cards and bank accounts, unless you detect suspicious activity.

### Where should I report suspicious or unusual activity?

The Federal Trade Commission recommends the following four steps if you detect suspicious activity:

<u>Step 3</u> - File a police report with your local police or the police in the community where the identity theft took place. <u>Step 4</u> - File a complaint with the Federal Trade Commission by using the FTC's Identity Theft Hotline by telephone: 1-877-438-4338, online at www.consumer.gov/idtheft, or by mail at Identity Theft Clearinghouse, Federal Trade Commission, 600 Pennsylvania Avenue NW, Washington DC 20580.

I know the Department of Veterans Affairs maintains my health records electronically; was this information also compromised?

No electronic medical records were compromised. The data lost is primarily limited to an individual's name, date of birth, social security number, in some cases their spouse's information, as well as some disability ratings. However, this information could still be of potential use to identity thieves and we recommend that all veterans be extra vigilant in monitoring for signs of potential identity theft or misuse of this information.

What is the Department of Veterans Affairs doing to ensure that this does not happen again?

The Department of Veterans Affairs is working with the President's Identity Theft Task Force, the Department of Justice and the Federal Trade Commission to investigate this data breach and to develop safeguards against similar incidents. The Department of Veterans Affairs has directed all VA employees complete the "VA Cyber Security Awareness Training Course" and complete the separate "General Employee Privacy Awareness Course" by June 30, 2006. In addition, the Department of Veterans Affairs will immediately be conducting an inventory and review of all current positions requiring access to sensitive VA data and require all employees requiring access to sensitive VA data to undergo an updated National Agency Check and Inquiries

(NACI) and/or a Minimum Background Investigation (MBI) depending on the level of access required by the responsibilities associated with their position. Appropriate law enforcement agencies, including the Federal Bureau of Investigation and the Inspector General of the Department of Veterans Affairs, have launched full-scale investigations into this matter.

See a 17 minute presentation of the sights and sounds of Derby Day on a 360 degree screen. Feel the excitement of the crowd and

hear the thunder of hoofs.

Visit the resident thoroughbred and view the Grandstand, Finish Line and Winner's Circle on a 30 minute guided outdoors tour

Inside the museum are many interesting artifacts of famous owners, horse farms, jockeys and trainers. There are also several interactive displays, including one that allows the viewer to select a replay of any Kentucky Derby race that has been filmed.

There are many great photo opportunities both inside and outside. There is a

very nice gift shop in the museum that sells Kentucky Derby items. The museum tour is handicap accessible, less strenuous and the guides are a wealth of information and derby trivia.

The tour fee of \$25 includes round trip transportation from the Galt House and admission to the Kentucky Derby Museum.

Other tours at extra cost (in addition to museum admission) include a one-hour backside tour and a tour inside the newly renovated clubhouse. The backside tour is limited to 12 and the clubhouse tour is limited to 20. Additionally, the clubhouse tour entails a great deal of walking and possibly some stairs. If there are not large numbers of other visitors and tour times fit our time constraints, it might be possible for some of our group to get tickets when we arrive.

### **WMA Bylaws Amendments**

### REF: ARTICLE 5, SECTION 1 - ELECTED OFFICERS

#### **Current Wording**

Officers to be elected shall be president, first vice-president, second vice-president, third vice-president, secretary, treasurer and financial secretary.

### Proposed Change/New Wording (underlined)

Officers to be elected shall be president, first vice-president, second vice-president, third vice-president, secretary, treasurer and membership secretary.

Rationale: To more accurately reflect the duties of the office.

#### REF: ARTICLE 7, SECTION 5 (2) – BOARD OF DIRECTORS, BOARD GOVERNMENT

#### **Current Wording**

Business may be transacted by mail when necessary; action taken by mail shall be ratified and made part of the minutes of the next meeting of the Board.

### Proposed Change/New Wording (underlined)

At the discretion of the Board, members of the Association – such as chapters and committees but not necessarily limited to these groups – may use the United States Postal Service or electronic means to transact business. This includes, at present: e-mail, fax and secure web pages as well as other generally accepted means that are not currently existent but may appear in the future. Members who do not have computer access shall receive notification via postal mail. Any action taken both electronically or via postal mail shall be ratified and made part of the minutes of the next meeting of the Board.

Rationale: Technology has progressed so much, that we now have the ability to communicate via means other than telephone and postal mail. Electronic methods should be included in this to shorten the length of time it takes to accomplish something, as well as increase the proficiency or our business practices. With the technology available to us today, as well as so many members having computer access, it would be in the best interests of the association to use whatever electronic method was available to speed up the process of getting business done, i.e., board votes on resignations, appointments, unusual expenditures, use of the WMA seal, etc.

#### REF: ARTICLE 9, SECTION 2 – ELECTIONS, BALLOTS

### **Current Wording**

The Nominating/Convention Site Committee shall prepare a ballot, a copy of which shall be mailed by 1 May of such year to each active member of record as of 1 April of said year; envelopes returning voted ballots must be postmarked no later than 1 June of such year.

### Proposed Change/New Wording (underlined)

The Nominating/Convention Site Committee shall prepare a ballot, a copy of which shall be mailed by 1 May of such year to each active member of record as of 1 April of said year; envelopes returning voted ballots must be postmarked no later than 1 June of such year. In the event only one person is running for each office the names will be published in 'Nouncements Convention issue and will be considered elected by virtue of the fact they are unopposed.

Rationale: To save the cost of preparing, mailing and returning ballot when electees are unopposed.

#### REF: ARTICLE 10, SECTION 2 (3 - 4) - FINANCE, DUES

#### **Current Wording**

(3) Active members shall receive a dues renewal notice from the financial secretary at least one month prior to the expiration of membership; renewal dues are payable at any time prior to or during the member's anniversary month. (4) When dues are not received prior to the end of the member's anniversary month, a delinquent notice shall be sent by the financial secretary. After a grace period of thirty (30) days, the member shall be dropped from the active membership rolls. A former member shall be reinstated with the anniversary month coinciding with receipt of dues.

### Proposed Change/New Wording (underlined)

(3) Active members shall receive a dues renewal notice from the WMA Database Administrator at least one month prior to the expiration of membership; renewal dues are payable at any time prior to or during the member's anniversary month.

(4) When dues are not received prior to the end of the member's anniversary month, a delinquent notice shall be sent by the WMA Database Administrator. After a grace period of thirty (30) days, the member shall be dropped from the active membership rolls. A former member shall be reinstated with the anniversary month coinciding with receipt of dues

Rationale: The financial responsibilities of the position have been outsourced. It is appropriate that the name be changed from financial secretary to the WMA Database Administrator.

### <u>REF: ARTICLE 12, SECTION 1</u> – CHAPTERS, WHO MAY FORM CHAPTERS

#### **Current Wording**

Five or more active members of this Association residing in the immediate geographic area may apply for a chapter charter. The Board may grant an exemption to the five member rule when the applicants are primarily aboard a military installation or in a limited access area.

### Proposed Change/New Wording (underlined)

Five or more active members of this Association who reside within a defined geographic area (e.g. state) or share a common USMC special interest/experience (e.g. music, aviation, drill instructor, deployed, etc.) may apply for a chapter charter. The Board may grant an exemption to the five member rule when the applicants are primarily aboard a military installation or in a limited access area.

Rationale: Deletes the "immediate geographic area" requirement to allow for Virtual Chapters (e.g. combining the members at large in the State of Virginia into a chapter that communicates electronically and may meet by conference call for (Continued next page)

the required two times per year meeting). We have at least two chapters who are already functioning in this manner. Adds the ability for special interest female Marines to combine to form a chapter, which may or may not be a 'Virtual' Chapter. This will allow better flexibility for the convenience of our Members at Large to communicate and connect through the use of available technology (e.g. e-mail, conference calls).

### <u>REF: PARAGRAPH 8</u> – BUDGET PREPARATION Current Wording:

The Third Vice President shall insure that a proposed annual budget is developed, in accordance with accepted business practice, and presented to the Board of Directors. After approval, a copy of the budget shall be available on request.

#### **Proposed Change/New Wording (underlined):**

The Third Vice President shall insure that a <u>proposed</u> <u>budget</u> is developed, in accordance with accepted business practice, and presented to the Board of Directors. After approval, copy of the budget shall be available on request.

**Rationale:** This change will allow the Board to develop budgets on whatever cycle is best for current situation and circumstances - e.g. bi-annually, annually, or semi-annually.

### **WMA Committee Reports**

**Bequest Advisory Committee** 

We approved nine requests for funds from the Bequest Advisory Committee in 2005-06 and returned one due to insufficient information. Three went to Marines in Iraq to provide things that they could not readily get on base; one for armed forces around the globe and the others dealt with things for veterans in hospitals such as televisions, things that help to enhance their lives.

WMA contracted with a Marine-run company named Hard Corps, Inc (HCI) to handle the technical aspects of providing online dues payment on our website (www.womenmarines.org). After moving our website to their servers, they began working behind the scenes with a duplicate copy of our site to set up the dues payment portion. After some fine tuning, we are anticipating this will be fully operational by July.

Having this capability also opens the possibilities of online payments for merchandise and convention registration in the future.

Although HCI is handling this addition, I am still the one making changes to the site. Along with online dues payment, I am also hoping to expand the current contents to include a memorial page, merchandise page and more history and photo-

graphs. My dream of re-designing the site has to be put on the back burner until I get other tasks completed.

The ECC's Energizer Bunny, Mary Ann Merritt, maintains our listsery. To date, the 344 members are almost 100 more than we had this same time last year. This has been a busy year for the History Committee. Since becoming chair in September 2005, I have been working with both the committee and CO-1 on the history project. Both have been delving into new areas. The following is a brief summation of the History Committee and our accomplishments and plans.

The balance of the fund set up by the estate of Lotus Mort is \$13,417.34. There will be a reduction of \$575.00 on the next statement for the fist ever Hamblet Award presented to Margaret Brewer at the Heritage Dinner in DC on 31 March.

While in DC for this dinner, I met with Lin Ezell, Director of the National Museum of the Marine Corps and we discussed the new museum, the Mort Fund and upcoming activities that WMA can be involved in at the new Museum.

Mitzi Manning and I met for lunch in DC and she indicates that she is still maintaining the Molly Marine history. I am hoping that within the next 8-10 months that we can expand the information on Molly and ascertain what needs to be done to preserve and improve the site in New Orleans. The report, if it develops on schedule, will be presented to the board at the convention for future review.

Judy Anderson and her competent crew are busy with the 2007 calendar on the music of women Marines and the WR Band. The CO-1 history project provided what materials they had on the band and music including a new item located while I was visiting the head archivist of the

Marine Corps at Quantico: a copy of the sheet music for "My Marine" written in 1943 was presented to the history project. Research is being done to locate a color copy and also what NY show this song was preformed in that year.

Judy Anderson indicates that her group would like to pass on the calendar project to another chapter in the near future. I will start looking for a group for this project. Judy has indicated that this project financially has become a break even venture for the chapter. It is an important way to tell our story but the entire effort will need to be reviewed if the participating chapter starts losing funds to produce it

Eleanor Wilson continues with the oral histories. I have not been able to reach her but others have indicated she will be busy taking more histories at the convention. I will continue to attempt to reach Eleanor and will relay any additional data obtained.

I met with both Mary Sue League and Pat Kelly and had a written email from Mary Sue on their recent activities. Both have worked with the Marine museum in the past to preserve uniforms and memorabilia that has been sent. This involved also working with individuals and families who wanted to contribute uniforms/memorabilia. Mary Sue and Pat have stated that they have not been active in the last year as their contacts at the museum have not needed or sought their help. Work on the new national museum has consumed all the museum staffs' time. They have indicated that they are going to be docents at the new museum and will no longer be able to continue

working with the WMA history project. I and WMA thank them for their years of service. I will be seeking replacements.

Lin Ezell and others indicate that they are well stocked on women Marine uniforms and items at this time. I suggest we should direct all inquires and donations of uniforms to the CO-1 history project at this time. CO-1 will have them cleaned and preserved and then given to the new Museum of the Marine Corps and other museums and displays as they are requested. Not cleaning and preserving the uniforms causes rapid breakdown of the fibers especially if they are folded in bags. The same with memorabilia. This will provide WMA with an opportunity to get copies of these often significant documents, before sending them on to

I have not been able to reach the lead of the Publication Committee but will send a report when I can reach her. I have been informed by the National President that a New Slim Jim is being produced.

The history of WWII, the Integrated Service Act years and the Korean Era is rapidly fading away. Many families are selling the treasures of our former members on the internet. Watching and making decisions on the value to our history of what is being sold can be a full time job. I have asked Sheryl Hobden to join our committee as our eBay eyes. Sheryl has a knack to locate those items that are rare. Sheryl will notify the CO-1 project of finds so that they can bid on specific items of note.

### Life Membership Review Board

As most of you know, the LMFRB long time recorder Olga Bullock became unable to continue her duties with this committee in the fall of 2004. Catharine Miller was kind enough to secure all the hard copy files which Olga had maintained for years and ship them to me. I attempted to find another member of this committee to handle this duty, but was not able to accomplish that task. I have therefore been functioning as both chairman and recorder for the past term.

I requested a complete life member listing from John Holvoet to verify that during Olga's last few months in the position of recorder all files had been updated. During this lengthy process I discovered quiet a few life members who had been deceased and listed in previous

Memorial Service booklets were still in the WMA database and the RM&D. I provided the date of death to John so he could correct the WMA database files.

I requested listings for all new life members from John Holvoet and he has been sending them to me monthly. I have made new cards for each new life member with her current address and life member number on that card, and filed it alphabetically. Whenever I learned of the death of a life member, either via internet announcement or via the pages of the quarterly newsletter 'Nouncements, I pulled her card and noted the date of death on the card and filed it in the Deceased Life Member File. If I didn't have a date of death, I searched the Social Security Death Index and noted that date, as well as reporting that date to John Holvoet for his files.

Before Olga became too ill to fulfill her duties as recorder, she and I had exchanged emails in regard to who was signing withdrawal statements for the WMA national treasurer, as she and I were the only ones with co-signing powers on the Life Member Fund account. Olga had told me at that time that she hadn't signed any and neither had I. When I inquired further about this, I was told by the WMA treasurer that she was doing online banking and it didn't require any signatures. I inquired about this practice to the WMA national president, but have never received an adequate response.

I have repeatedly requested the WMA chaplain to send me a listing of deceased members and I would receive a listing

and then months would go by and I would again request a copy of this listing. I have not received any listing in almost a year, so either life members are not dying, the WMA chaplain has not been informed of their deaths, or I just can't get a listing.

Therefore, in regards to the current WMA SOP, LMFRB:

A. Item #2 of the SOP states that the recorder shall maintain an on-going review of the receipts and withdrawals: I have maintained a listing of life members enrolled, but not deceased, nor withdrawals as I have never received these items

B. Item #3 (a) of the SOP states the chairman and recorder shall be provided withdrawal statements indicating the transfer of funds to the General Fund of \$15.00 for each new life member: I have never received any listing of withdraws to indicate a transfer of funds.

C. Item #3 (b) of the SOP states the chairman and recorder shall be provided

withdrawal statements for the \$50.00 transferred to the Scholarship Fund on the demise of a life member: I do not know if the \$50.00 has been transferred to the WMA Memorial Scholarship Fund on the demise of a life member. I have received no request for a withdrawal, or notification that monies have been transferred, or a listing of the names of any deceased life members from the WMA treasurer.

D. Item #3 (c) states the chairman and recorder shall be provided withdrawal statements when the interest is transferred on 1 July: I cannot verify the amount or if any interest off the Life Member Fund was transferred for the past two years on 1 July to pay the annual dues of life members as provided for in WMA Bylaws, Article Ten: Finance, Section 3(2).

E. Item #4: states that withdrawals can only be made upon the signature of the treasurer and one other designated member of the LMFRB: I have no idea who might be signing withdrawals on this account, or if anyone is. To my knowledge, only Olga Bullock and I have co-signing powers on this account

with the WMA treasurer.

F. Item #5: To my knowledge, the LMFRB has fulfilled the requirement that a member of the LMFRB serve on the Financial Advisory Committee, as Carol Mutter is a member of the LMFB and a member of the Financial Advisory Committee. As chairman and recorder, I have received no recommendations from the Financial Advisory Committee.

G. Item #6: The members of the Financial Advisory Committee have submitted no recommendations to the LMFBR for the investment of the Life Member funds.

H. Item #7: It is required that the chairman of this committee report to the convention the status of life member enrollment and Life Member Fund. I can report that as of 10 May 2006, we had enrolled Life Member # 2720. I cannot however report how many of those 2,720 are still living members of the Women Marines Association. Nor am I able to report the status of the monies in the Life Member Fund or where they are invested

Another responsibility of the IPP is to put together the ballot for the next slate of national officers, to include area directors and the proposal for the 2010 national convention. Goal #3: Improve WMA chapter flexibility for the convenience of our many members-at-large (MAL) and those who have never connected to a local chapter for whatever reason by allowing area directors to organize and form "state chapters-at-large" for each state in their areas (especially ideal option for those states which have never been successful in organizing traditional local chapters), and to allow more coordinated/responsive communication, and more state-specific information sharing with membersat-large in a virtual/flexible chapter structure that meets and networks via email; supports state-wide veterans and Marine service projects from the convenience of their computers/homes; and keeps members in closer touch with area

- Since September 2004, it has been the goal of this office to increase membership and general awareness of WMA. This is being accomplished in the following manner: target any online articles about women Marines. Pass the information on to area directors and chapters and Linda Lacy for the book "We are Marines". Personal contact is made as well with email letter explaining WMA and inviting them to check out the website and join our organization. Forums that target Marines are also checked

weekly and information passed in regards to our chapters, ongoing events and conventions.

- Work with chapters and area directors to find weak areas within the chapter and help to rebuild. Work to set up projects that fit a chapter. Show and write press releases as well as give information as to whom and how to submit information along with timeframe. Packets were sent to every area director and board member. Press releases for the 63rd anniversary were sent to a newspaper where we have a chapter. Releases also sent to states with no chapters and national given as point of contact. Have offered my help to any chapter or area director.


