LCpl Maria Lauterbach: One of our Own



The story of LCpl Maria Lauterbach was still unfolding at press time for the last newsletter. The sad news of her tragic death at the hands of another Marine was felt "to the Corps" by all of us.

You have seen and read all the news regarding this tragedy, including the news of the capture of her alleged killer in Mexico. This is not going to be re-hashed here.

This all too brief item is to remember a 20-yr-old woman who was adopted as a toddler and never sat still. The bold, lively child was

constantly climbing things and jumping off them. Maria loved sports, excelling in soccer and softball in high school.

Maria knew before she graduated from high school that she wanted to be a Marine, but did not like being so far from home. Home was very important to her, and joining the Marine Corps was her first venture away. The vivacious child who was hard to

keep down was remembered by members of her church congregation for her strength, vitality and independent spirit.

The flag-draped casket bearing her remains and those of her unborn son, Gabriel Joseph, were laid to rest in Calvary Cemetery, Vandalia, Ohio on 2 February.

LCpl Lauterbach was assigned to the 2nd Marine Logistics Group of the II Marine Expeditionary Force at Camp Lejeune

when she and her unborn son were murdered. She joined the Corps in June 2006 and served as an admin clerk. She never deployed to Iraq.

Another Loss in Iraq

On 2 May we lost 22-yr-old LCpl Casey L. Casanova, McComb, Mississippi, to yet another roadside IED attack, along with three other male Marines.

LCpl Casanova joined the Marine Corps in December 2005 and was a field radio operator assigned to Combat Logistics Battalion 1, Combat Logistics Regiment 1, 1st Marine Logistics Group, I MEF, Camp Pendleton. She was deployed to Iraq with her unit on Valentine's Day of this year and was engaged to be married in September.

There were six 6 foot tables full of gifts and a huge basket with gift cards and well wishes from all over the country. The twins were born three days after the shower and are doing wonderfully. Sydney and Olivia were baptized on 13 April and they consider Marines everywhere their family. Thank you to everyone who participated with prayers and gifts. It really showed how we take care of our own.

Financial Advisory Committee Update

In continuing to enlighten you on the financial operations of WMA, I want to assure you that the Financial Advisory Committee (FAC) is actively researching ways to streamline the funds and obtain the best return rates during these volatile times for investing to meet our budget objectives while protecting our capital. The three funds to be addressed here are the General, Life Member, and Scholarship Funds.

The General Fund was established to pay all authorized WMA expenses. This account is funded through earnings from the Restricted Reserve Fund, term dues, earnings from the Life Member Fund, and donations.

The Life Member Fund is funded by dues received for life membership. Per the bylaws (found in your Resource Manual & Directory (RM&D)), the earnings are withdrawn annually (1 July) and transferred to the General Fund. The current one year dues amount (\$15.00) is transferred to the General Fund for each new life member and upon the death of a life member, \$50.00 is transferred to the Memorial Scholarship Fund in memory of the deceased member.

The Memorial Scholarship Fund currently has five separate scholarship designations:

WMA Memorial Scholarship Fund was established from donations, earnings on the principal, and the Life Member Fund.

Ethyl and Amin Wiebke Memorial Scholarship established in 1987 from the estate of Ethyl Wiebke.

Lily Gridley Memorial Scholarship established in 1996 from the estate of LtCol

Lily Gridley.

LaRue Ditmore Music Scholarship established in 1999 from the estate of LaRue Ditmore.

The Major Megan McClung Scholarship established in 2007 by Dr. and Mrs. Michael McClung in memory of their daughter, the first female Marine officer ever killed in a combat zone.

Named scholarships can only be established upon receipt of adequate funds to award at least one \$1,500 scholarship per year for at least 10 years. Additional information on scholarships can be found in the RM&D.

The program closed with a placing of the wreath by WWII member Marian Landry and Cpl Ivelisse Colon. Melanie Young was the event coordinator. The granddaughter of the sculptor, Enrique Alferez, was also in the audience.

Army Medic receives Silver Star

Twenty-year-old Army Specialist Monica Brown from Lake Jackson, Texas, a medic in the 782nd Brigade Support Battalion, 4th Brigade Combat Team, 82nd Airborne Division became the first woman

in Afghanistan and only the second woman since World War II to receive the Silver Star, the United States' thirdhighest medal for valor. After a roadside bomb detonated near a convoy of Humvees in the eastern Paktia province, Brown saved the lives of fellow soldiers in April 2007 by running through insurgent gunfire using her body to shield wounded soldiers while mortars fell nearby.

SPC Brown's efforts to first shield the wounded and then move them to a safer location several hundred meters away in order to assess and treat them, earned her the second Silver.

She was presented with the medal by Vice President Dick Cheney in a ceremony on March 21, 2008.

10 November, 2007: What a Ball!

Orsini named Wounded Warrior Program Director

Retired Marine, Patricia Orsini was named director of the House of Representatives' Wounded Warrior Program. The program first was announced last November, on the eve of Veterans Day, by House Speaker Nancy Pelosi and other lawmakers. The aim is to bring 25 people on board by the end of September and 50 more in the following year.

Orsini, 51, a 30-year veteran of the Marines from Bellmawr, N.J., is a retired master gunnery sergeant with considerable experience helping injured and disabled service members make the transition to civilian life. In addition to helping the wounded, she has honored the dead. Orsini in recent years has escorted the remains of fallen Marines from Dover Air Force Base



in Delaware to their hometowns for burial. Earlier in her career, she sounded "Taps" as the bugler at military funerals.


Brenda Moore and I traveled to Camp Lejeune to staff the WMA booth at the Marine South Exposition from 2 - 3 April.

No story is too small or insignificant for preservation. Dian has also been asked to pull from Yahoo! and maintain for preservation the obituaries posted on our members. These final looks at the lives

of our women Marines have valuable data in them. Obituaries are also saved by our National Chaplain.

WMA has a strong Oral History Program started by Eleanor Wilson utilizing the technology of the day (recorders). Our new lead of the Oral History Program, Loretta Krook, has moved us into the era of DVD visual oral histories. This new program will carry us forward with the technology of the present as well as the future. Loretta will be needing volunteers for the 2008 Houston Convention. Can you help? It will only add to your enjoyment of the convention.

A new project in need of volunteers is to take the autobiographies in the three WMA Pictorial Books done by Mary Bacon Hale and have chapters help with

recording of the stories provided by our women for inclusion in the many national oral history programs. Acceptance by the national programs for these read stories (a first) will save hundreds of stories that would have been lost. This project is only possible since the women wrote their own autobiographies, so it is their story in their own words.

Every one of us has a story and we need to hear about them. Put them on our WMA Yahoo! listserv site, or call Nancy Wilt, Loretta Krook or Dian George about getting your story saved. Be a part of it all and add to the stories of the women called Marines.

B-24 Liberator Plane Crash

I am writing regarding an article in the WMA 'Nouncements, summer of 2007. As usual, here I am putting it off till February of 2008 -- what a straggler!!! The article was one that Jane Baird Silva, formerly of OUR base, MCAS Miramar, wrote many, many years ago. This is an addendum to her article.

Jane wrote of two women Marines who crashed off San Diego in a Liberator bomber from Kearney Navy Base which was right next to Miramar. Those two women were PFC Edna Shaughnessy, originally from New Hampshire, and PFC Helen Breckel, (I think from Ohio but not sure). Edna and Helen lived in the same wing in the barracks as I did, and Edna and I worked together in the base switch-board office.

All of this was in WWII -- not sure of the actual dates but we were all there during late 1943 to 1946. On the date of the crash, Shaughnessy and I were to work together on a night shift at the office. I was on duty in the office at the appointed time -- no Shaughnessy. I knew she and Helen had intended to go up on that plane that morning and, since Shaughnessy was a most trustworthy gal and would not miss work, I just figured, just perhaps, they might have been gone longer than they had expected and decided not to call in her absence at work yet. Hearing nothing from her, finally I decided to call the flight line at Kearney to see if the plane had come in.

I made that call and was totally shocked to hear "the plane is presumed missing"!

Then I knew I had to make that call to the Officer of the Day. The plane the girls had been on was not even being heard from! My heart sank.

All of us in that wing in the barracks were awake whenever anyone came across the entrance to our wing -- could it be Helen and Edna? As Jane's article stated, prayers went up all over the base, not just in the barracks or the office. The rest of the story was in the article and in the newspaper article Jane had sent too. Finally seeing those two very familiar faces was a joy.

Many stories came out of that crash -- one that I remember was that, when the plane crashed, the girls lost their shoes and the island was a very craggy, rough place to attempt to walk and so they fashioned their purses into shoes in order to move across the island.

They had been so attacked by all the bugs on the island that their faces were as red as could be -- but faces that looked pretty beautiful to us and all of us so grateful for their lives having been saved by the fishing boat!

Sgt Betty Mahoney Raines (P.S.: Now am so full of joy for having the Marine Corps experience -- I belong to OK-2 and am an active almost 85 years young WR who married the Commander of the Guard at Miramar, GySgt Bob Raines.)

What did I do, by saying those three words, "Let us pray"?

It is my desire that we as Marines remember one another by beginning and ending each day with these words. How many times in your life as a Marine and since has a chaplain appeared before you and said, "Let us pray."

I begin and close each day as your Chaplain with the words, "Let us pray"FOR YOOOU.

Dr. Fleur Sack - graduated from medical school in South Africa prior to immigrating to the United States with her husband and two sons in 1976; completed her residency in family medicine at the University of Miami and was in private practice until joining the VA in 2005; an advocate for Women's Health issues, Dr Sack was the Medical Director for the Women's Health and Fitness Center at Baptist Hospital in

Miami; authored a book about women and AIDS in 1992 and was a recent editor of a monograph on osteoporosis.

John Roberts - served in the Marine Corps from 1982 to 1996; received a medical discharge following a prolonged recovery from wounds suffered in a helicopter crash in the seas of Somalia at the beginning of Operation Restore Hope, suffering third-degree burns over 80 percent of his body, resulting in the loss of use of his left leg and right arm; following military service, first job was with the Disabled American Veterans, working as a National Service Officer in the organization's office in Houston; Veterans



Service Representative with the U.S. Department of Veterans Affairs (VA); became Supervisor of the VA Regional Office; left the VA to become National Service Director of the Wounded Warrior Project (WWP); responsible for all WWP staff assigned in the field to major military trauma facilities across the country; leads WWP's Claims Program, as well as its WWP Outdoors and Wounded Warrior Disabled Sports Project programs.

Betty Moseley Brown – served in the Marine Corps from 1978-1992; VA career began at the San Diego Regional Office where she was a Veterans Benefits Counselor along with serving as the Women Veterans Coordinator; left the VA and worked for the Navy, Naval Facilities Acquisition Command in San Diego and as Director, Acquisition Career Management Center in Arlington; returned to VA in 2001, and worked as a



Program Analyst in the Veterans Benefits Administration (VBA) Compensation and Pension Service; in 2002, served as the operational assistant and advisor to the Associate Deputy Under Secretary for Policy and Program Management; served on the Secretary's Seamless Transition Task Force, VA-DoD Benefits Executive Council, and was the VBA contact for the Army's Disabled Soldiers Support System; has a Doctor of Education degree from the University of Sarasota; currently Associate Director of the Center for Women Veterans.

Katherine (Kathy) Van Gorder joined WMA in the early 1990s as a
member at large; has since held the
office of treasurer and news editor
with PA-2 since its formation in April
2006; in 2007, accepted the appointment as WMA National Assistant
Deputy VAVS Rep; life member
of the Marine Corps League, she
was asked to represent WMA as the
WMA Liaison Officer to the League
in 2006; in early 2008, accepted the
responsibility as Area 2 Director.




