WIMSA Chairs Update



Our History Keeps On Growing

Before I get too far into the exciting new history items we have obtained, I need to address a special thank you to those who sent checks to help with preserving our history. A total of \$500.00 was received in amounts ranging from \$10.00 to \$400.00. Our grateful appreciation to all of you. We will use the funds wisely.

WWI TREASURE

We now have 31 photos of a WWI woman Marine visiting Parris Island in 1918 thanks to winning a bidding war on eBay. The pictures were taken with a small camera (non-professional) but they are fantastic shots of Sergeant Martha Wilchinski inspecting a male squad, running a rifle charge with a group of male Marines, as well

as shooting at the rifle range with various weapons and with male Marines at various places around Parris Island. Some of the shots are of male Marines and Parris Island only but provide glimpses of how young a base PI was in those days, a fairly new command

with mostly wooden buildings and tents.

One photo in the group is from the Washington, DC area and has three WWI women Marines standing on a bridge in what appears to be very cold weather. The entire group of photos provides a snapshot of our past history.

WMA Member Presents Major Uniform Donation

WMA member Sara Phoenix has sent us three full boxes of her uniforms including the pin stripe of the 1970's, the navy blue pants and powder blue shirt utility uniform with hat and sweater, her initial officer dress whites, a winter alpha uniform of the period and many other treasures. Many of these we did not have and they add much to the collection. The navy blue utilities are especially rare. This uniform was worn by the navy women of the day as their utility uniform. When the women Marines needed a new utility uniform the Navy stepped up and offered theirs as a cost saving option. Sara also sent the 1970's drill shoes (oxfords) that we did not have in the collection. Thanks you, Sara.

Women Marines Crash at Sea in Liberator Bomber

Jane Baird Silva sent us an autobiography of her time on active duty in WWII. Included in the report is the newspaper article of the crash of a Liberator bomber at sea which had 2 women Marines on board. The Liberator was on a weather patrol off the coast of California when it crashed at sea, 330 miles from San Diego. Eleven Navy crewman and 2 women Marines were on board the plane. After the crash, the plane sank immediately and the survivors crowded into one raft. To make room for our women Marines, other crash victims swam holding onto the raft until they could walk ashore on Isle de La Guardia Island. They were on the island for three days living on raw fish and clams.

Finally, some crew members took the chance of rafting out to find help. They did get help in the form of a fishing boat that rescued them and those on the island and took them to a Mexican Army Post of Babla de Los Angles and turned them over to General Juan Rico, the military commander of Baja California.

By this time our Navy had stopped search and rescue operations. It is reported by Jane in her autobiography that the night before the rescue one woman Marine

at the barracks gathered her fellow women Marines and required them to say a rosary with her for the safety of the downed plane. Their rescue was announced the next morning. The women

Marines rescued were PFC Edna Shaughnessy and PFC Helen Breckel.

WOW! What a great piece of history. If you know these two WWII women Marines, please tell us more of this story or how we may reach them. And many thanks to Jane Silva for sharing her story and the crash story with The History Project.


Book Review: "Band of Sisters"

They command C-130 squadrons; fly combat missions in F-18s, Cobras and Kiowas; man 50-caliber machine guns in turrets on Humvees; check and clear buildings and get involved in fire fights; and moving aircraft around on the flight deck of a carrier, they risk being blown overboard with one misstep. They love their country and serve it proudly. They sacrifice, sweat, love and die, just like their brothers and their stories are told with candor, honesty and raw emotion in the new book "Band of Sisters - American Women at War in Iraq", published July 4th. Written by Kirsten Holmstedt and published by Stackpole Books, the book profiles the experiences of twelve women (Marine, Army, Navy and Air Force) who have served in Iraq.

Following September 11th, author Kirsten Holmstedt became immensely curious about the experiences the largest contingent of women who have ever served our country were having and found that the information available from conventional sources left her wanting more. From her vantage point as a resident of Jacksonville, NC, home to Camp Lejeune, she started to seek out those who were just back from Iraq and ended up during the course of three years, traveling to MCAS Beaufort, Pope Air Force Base, Ft. Bragg and off the coast of Florida,

of the women were happy to share their stories, others needed convincing and a few declined. The end result is a compendium of stories as different as the women who experienced them and I consider this a must read book.

CLB-13 Marine serves 5th tour in Iraq

With Marine Corps operational tempo at an all-time high, there are Marines out there who don't mind the deployments-- even after five of them.

Sgt Tasha Monz, field radio operator for Combat Logistics Battalion 13, 13th Marine Expeditionary Unit and six-year veteran of the Marine Corps, is currently serving her fifth tour in Iraq.

"Anything that a Marine can do out here, she has done," said Capt. Michael D. Pitre, officer in charge of Monz, about her experience and leadership she brings to the table with five deployments under her belt. on the Blue Force Tracking system inside "She's great!"

As one can guess, the climate in Iraq has certainly changed since her first deployment

during Operation Iraqi Freedom II.

"The Marine Corps has come a long way (in Iraq). The people of Iraq have grown to appreciate us rather than being afraid and angry with us," said Monz, a Cincinnati, Ohio native. "I remember doing convoys in OIF II and getting rocks and all sorts of things thrown at us. Now we get waived at and offered gifts."

She also noted the cities have been cleaned up a great deal and believes we aren't the only ones who understand what's being done here.

Monz has already made plans to stay with the 13th MEU for their next scheduled deployment in 2008. Number six...?

Nurse death reflects new female roles

Capt. Maria Ines Ortiz, a New Jersey native and the first military nurse killed by hostile fire since the Vietnam War, was buried with full honors at Arlington National Cemetery on 9 August.



The death of Ortiz, who has been described as a tireless patient advocate with an infectious smile, represents a paradox in the war. Although she was the first female nurse to die in combat in Iraq, 71 other women in specialties ranging from military police officers to truck drivers have been killed there since the U.S. invaded the country in March 2003. Eight female service members have died in Afghanistan since that invasion in 2001. In America's previous wars, nurses were generally the only women to die.

In Vietnam, eight nurses died in the line of duty. During World War II, more than a dozen American nurses were killed and more than 75 taken prisoner.

In Iraq, however, women were under fire from the start. Less than 72 hours after the invasion began, Pfc. Lori Ann Piestewa was killed. Since then, women serving in Iraq have been killed by mortars, grenades, snipers and suicide bombers as they worked to defuse roadside bombs.

Ortiz was assigned to a surgical hospital inside the fortified Green Zone in Baghdad. She was off duty and walking outdoors when the mortar struck, her family said.

Born in Camden, Ortiz grew up in Puerto Rico and enlisted in the Army in 1991.

First women's names added to USNA memorial

Marine Capt. Jennifer J. Harris never attracted special attention for being a woman throughout her career at the Naval Academy and in the Marine Corps. So it was appropriate, friends said, that she was not singled out in death, when the academy put her name among hundreds of others on a marble tablet that honors graduates killed in action.

Harris is the second woman in school history to be added to the list, which includes 954 men dating to the Civil War. The first woman, Maj. Megan M. McClung, was a combat death in December. The two women mark a grim milestone, as combat roles in the military have opened to women since they first arrived at the academy 31 years ago.

Called the academy's *sanctum sanctorum* or *holy of holies*, Memorial Hall is the first stop for alumni who come to Annapolis. Midshipmen

sometimes go there to ponder what the future holds for them, as well as to consider the sacrifices of those who went before. Plebes, or incoming freshmen, are not allowed to enter the room until they undergo orientation from upperclassmen about what it means.

The hall is located at the heart of the academy at the entrance to the Bancroft Hall dormitory, up a granite staircase in a domed

room filled with busts of notable admirals and paintings of naval battles. A marble panel for each class lists each fallen comrade, whether a combat death or an accident while on active duty.

The Killed in Action tablet is the centerpiece, behind a glass case under a likeness of the blue standard flown in 1813 by a beleaguered commodore, urging his sailors: DONT GIVE UP THE SHIP.

The Naval Academy Alumni Association and Foundation, with private funds, maintains the panels and updates them every six months, using official descriptions from the Pentagon to determine who will be added to the KIAs.

Most of those on the list were killed during World War II, many during the attack on Pearl Harbor or the Guadalcanal campaign. Most were junior officers serving as Marines or

naval aviators, killed shortly after they left the academy. There are 12 names under Global War on Terrorism.

Without fanfare earlier this month, a craftsman added Harris' name and that of two others, 1st Lt. Travis J. Manion and Maj. Douglas A. Zembiec.

The process of becoming an American citizen became easier in 2002, when President George W. Bush signed an executive order that expedited the process for service members serving during wartime. The U.S. Citizenship and Immigration Service has naturalized more than 32,500 members of the U.S. Armed Forces since the beginning of the global war on terrorism, according to a USCIS press release.

- square may shrink to a less than ideal size
- Iron, if necessary, before cutting your square.
- Raw (unfinished) size is a square measuring 12.5" X 12.5".
- All decoration or writing must fit inside the **finished size of 11" X 11"**.

TIP: Cut a small slit in the material and then rip it. That ensures that your edge is straight. This is done running with the grain. The grain is the straight side of the material.

Veteran News

A presidential commission is pushing for some broad changes to veterans' care.

The panel's plan is to boost benefits for family members helping care for the wounded, establish an easy-to-use Web site for medical records and overhaul the way disability pay is awarded.

Meanwhile, the Senate has passed a bill designed to end inconsistencies in disability pay for veterans. It also would boost severance pay and pony up \$50 million for improved diagnosis of veterans with brain injury or post-traumatic stress.

The House is mulling over similar measures.

To address a shortage of nurses across the nation and ensure that veterans continue to receive personalized, world-class care in Department of Veterans Affairs (VA) facilities, VA has announced creation of a new multi-campus Nursing Academy.

A five-year, \$40 million pilot program will establish partnerships with 12 nursing schools across the country during the next three years, beginning with four for the 2007-2008 academic year. The VA nursing academy is a virtual organization with central administration in Washington and teaching at competitively selected schools across the country who partner with VA.

Homeless veterans may soon qualify for special Section 8 housing vouchers under a measure approved by the Senate Appropriations Committee.

To apply for the vouchers, veterans would contact the Veterans Affairs Department, which would screen applicants for eligibility and then manage cases. The Housing and Urban Development in turn, would distribute the rental assistance.

If enacted, the funds, which total \$75 million, should help provide housing for 7,500 veterans.

The committee unanimously approved the measure, but it is not yet scheduled for a floor vote by the full Senate. The House version of the bill does not contain the housing vouchers provision, which means this will be one of the many issues that will be negotiated in a House-Senate conference to craft a final compromise bill.

To ensure veterans with emotional crises have round-theclock access to trained professionals, the Department of Veterans Affairs has opened a national suicide prevention hot line for veterans.

The toll-free hot line number is 1-800-273-TALK (8255). VA's hot line will be staffed by mental health professionals in Canandaigua, N.Y. They will take toll-free calls from across the country and work closely with local VA mental-health providers to help callers.

To operate the national hot line, VA is partnering with the Substance Abuse and Mental Health Services Administration of the Department of Health and Human Services.

The suicide hot line is among several enhancements to mentalhealth care that Sec. Nicholson has announced this year. In mid-July, the department's top mental-health professionals convened to review the services provided to veterans of the war on terror.

TRICARE Data Compromised

Data for nearly 600,000 households enrolled in TRICARE stored on a government-contractor's unprotected computer server could have been exposed to hackers, defense officials announced today.

Beneficiaries' names, addresses, Social Security Numbers, birth dates and some health information was stored on a computer server that was not using a firewall and did not have adequate password protection, TRICARE Management Activity officials said.

Officials disabled the server in May, and it is no longer used. Forensic analysis of the server found no evidence that any beneficiary information was compromised, said Leslie Shaffer, assistant privacy officer at the activity.

Science Applications International Corp. (SAIC) maintained the data in Shalimar, Fla., and used it to process several military health care contracts, including those for customers in the Army, Navy, Air Force and Coast Guard. The server allowed for File Transfer Protocol transmissions of the data to its contract customers.

This is the first time SAIC has violated Defense Department computer security procedures, Shaffer said.

The TRICARE security breach was discovered after contract customers reported non-secure transmissions of data. SAIC is investigating and some employees have been placed on administrative leave pending the outcome, a company release stated.

DoD and SAIC mailed letters to beneficiaries whose data was put at risk. An incident response center has been setup to field customer's toll-free calls and information is available through a Website for those who suspect identity theft, or who want to protect themselves from identity theft

Beneficiaries who were put at risk are

also being offered a free, one-year subscription to an identity restoration service, she said.

The incident response center can be reached toll free within the United States at 1-888-862-2680, or collect at 1-515-365-3550 from outside the United States.

(From Carol Mutter: -- "I just got my form letters from SAIC and the TRICARE Management Activity of DoD Health Affairs saying my information was among the data that may have been compromised. They have automatically enrolled me [and everyone else in that data base] with membership in ID TheftSmart.

A membership card was included in the letter. Bottom line: if your information was potentially compromised, you should have received a similar letter. Additional information is at 888-862-2680 or www.saic.com/response.")

Raytheon Outreach Effort Helps Wounded Veterans

Thousands of military service members returning from Operation Enduring Freedom in Afghanistan and Operation Iraqi Freedom have sustained injuries that require them to retire from the military and to re-evaluate their careers.

To help these veterans make this transition, the Department of Labor's Military Severely Injured Center (MSIC) in Arlington, Va., has launched an online employment and education resource, the MSIC Career Center that functions as a "one-stop-shop" for resources and services provided by the MSIC.

As part of its commitment to both the military and diversity, Raytheon is working with MSIC and using the Career Center to actively recruit veterans with severe injuries and disabilities. Raytheon has:

- Implemented a formal process to deliver job opportunity information sessions via MSIC resources;
- Established relationships with MSIC job counselors and patient assistant team liaisons at Washington D.C.-area military hospitals;
- Added candidate source values on Rayjobs that give wounded

veterans the opportunity to self-identify when they apply for a job opening; and

• Been listed on the databases and websites of resources supporting wounded veterans, including Marine for Life; the U.S. Army's Wounded Warrior Project, the U.S. Navy's Safe Harbor, the Department of Labor's REALifelines and HireVetsFirst.

Leading Raytheon's outreach effort is Human Resources' Bob Foley, a retired U.S. Marine and combat veteran of Desert Storm.

To date, more than 300 veterans with disabilities have applied for Raytheon jobs. Of this number, six have been hired, and many others are in consideration.

Raytheon's efforts on this front are expanding. Raytheon Senior Vice President and CFO Dave Wajsgras has formed a relationship with the MSIC and Creating Opportunities by Recognizing Abilities to establish a program to hire veterans with disabilities in telework roles for the Financial Shared Services team in Plano, Texas. A program pilot will begin shortly.



"Jennifer Harris reflected four words," said the Rev. Dean Pedersen on Memorial Day. "Those words are vision, empathy, grace and gratitude."

Swampscott formally and gratefully remembered U.S. Marine Corps Capt. Jennifer J. Harris on Memorial Day as hundreds stood in a light rain to dedicate a square at the intersection of Essex Street and Stetson Avenue in her name. Pedersen, pastor of First Church in Swampscott and a retired U.S. Navy chaplain, served as master of ceremonies.

Pedersen read a statement from Jim Schultz, the town's veterans' affairs officer. He recalled her med-evacuation of more than 700 soldiers in her less than 6 months in Iraq.

"Swampscott, the United States and

the world are a lesser place without her," Schultz wrote. "She died doing the two things she loved most: flying and helping people."

Family members unveiled the plaque marking the newly named Harris Square.



A small Pacific island that was the site of the Marine Corps' bloodiest and most iconic battle will remain "Iwo Jima" on U.S. maps, according to a congressionally authorized committee that reviews names on maps.

The ruling follows the Japanese government's June 18 decision to refer to Iwo Jima as Io To, which was its pre-World War II name. The change was made at the request of the island's former residents.

The confusion over the island's name began more than 60 years ago, after Japanese officers started referring to the island as Iwo Jima when they arrived to protect it from U.S. forces during World War II. When the war ended, the new name remained.

Both names mean "sulfur island," however, "To" indicates the island is smaller than "Jima" would imply. Iwo and Io both mean "sulfur," but Io is more accurate based on the original Japanese writing system. The Committee on Foreign Names, under the U.S. Board on Geographic Names, decided to retain the name Iwo Jima on U.S. maps since it's so well-known.


WA-1 The Evergreen State
