Senior Olympian Gives Athletes a Run for Their Money

We have a world-class athlete in our ranks! CA-2 member Frances (Fran) Styles, competed in the National Senior Games in Houston, TX, June 17-24. Fran won medals in basketball and track and field events.

Fran was commissioned a second lieutenant in 1953 and her first duty station was Marine Corps Recruit Depot San Diego. She was assigned to the duty of Depot Education Officer, but that wasn't her only job. Fran was put in charge of women's sports teams on the base. Having been a physical education (P.E.) teacher before she joined the Marine Corps, this was right up her alley.

Fran studied P.E. at the University of Oregon. "As P.E. majors, we had to qualify as an umpire or referee for two different sports, but we couldn't play any." When she taught middle school,

girls still could not compete. When Fran retired, she was a track official who was assigned to officiate a meet at the Olympic Training Center in Chula Vista, Calif. She saw athletes competing and said, "Good grief! I can do this, too!"

The Senior Games are set up by local organizations, such as the San Diego Senior Women's Basketball Association, of which Fran is also a member. Participants must win on the state level in order to qualify for national competition. National competition takes place every two years. This year, Fran came home with five medals for track and field and her basketball team won a gold medal.


Happy Holidays!

Janet's Journey

JANET TAYNOR, USMC WWII, WAS BORN IN YOSEMITE, CALIF. ON MARCH 25,1927 NEAR EL CAPITAN.

Little is known of her life until she joined the Marine Corps on her 17th birthday in 1944. She used her sister's name because she was too young to join. Her patriotism and devotion to country ran deep, as did it for many Americans in those days.

Janet served in motor transport and probably attended boot camp at Camp Lejeune. Little else is known about her service. Once the war ended, Janet became a member of the Scuttlebutt Club, which bound women of the Corps together and helped them stay in touch until the Women Marines Association (WMA) was formed in 1960.

Janet was a founding member of WMA

and in 1960 helped to plan the first convention in Denver. She also provided valuable support to me in planning the 2010 Convention. She was a trusted confidant and friend throughout my term as a WMA member (since 2000). She was a founding member of the Marine Memorial Association (Golden, Colo.) and helped to get the Marine Memorial in Golden, Colo. built. She was also a founding member of detachments of the Marine Corps League in Colo. Janet was instrumental in getting the first AIDS respite completed in CO and served over 40 vears as a CNA. She received numerous awards for her thousands of hours of volunteer work at the VA. And she provided valuable support to many young women throughout her life to get them on their feet and

We know that she was married several times and her last husband, Dave "High Pockets," passed away in the early fall of 2010. Of her 9 children, she is survived by 4 living children - Kristin Carmack, Fred Pebley, Lynn Tucker, and Cheryl Arcemont - numerous grandchildren and great-grandchildren. There are 3 deceased children and 2 other children with unknown location/living status.

out of bad situations.

Janet passed away on March 13, 2011 from a stroke. Her last wish was to have her ashes spread at Yosemite

where she grew up and where she knew she would feel at peace. Her daughters, Kristin and Cheryl, contacted me and asked if there was any way we could help. I replied, "She was a Marine and I'm sure Marines can help make her wish come true. That's what we do!"

AND SO, THE LAST LEG OF JANET'S JOURNEY BEGAN. The wheels began turning--an invite from Sybl Acree (President WMA CA-8) and Helen Page (National Secretary of Loyal Escorts) to stay with them came to mind and they agreed--housing was taken care of! Then I contacted a CO-1 friend, Tom Allee, who is now with the Center for American Values in Pueblo, Colo. He has been a supporter of our CO-1 chapter for over 7 years, and while working at Frontier Airlines, provided prizes for our 5K when we conducted the first few runs. He helped to obtain inexpensive fares on Frontier and put us in touch with the appropriate people at the Denver Airport to accomplish our mission. Meetings were conducted with the Marine Memorial leadership, the Young

Marines and Marine Corps League and a plan was formed.

31 May 2011 – The Young Marines presented Janet's ashes for a special salute



at the Marine Memorial before a crowd of over 200 people who had come to honor the fallen. Special flowers were placed around

the WMA boulder at the Memorial in her honor and the ceremony went off without a hitch, thanks to the efforts of those great Young Marines. Learn more about the Marine Memorial at http://usmarinecorpsmemorial.com/.

AFTER MEMORIAL DAY, WE WORKED TO FIND A GREEN BLAZER AND PATCHES TO CREATE A "UNIFORM" WORTHY OF WMA AND THIS SPECIAL MARINE. We located one at Blazer.com, ordered it and received it just in time. We put the 10" WMA patch on back, the Woman Marine Patch from USA-3 on one sleeve and the "Circle of Friends" WMA patch on the other. A white military blouse was added with a crisscross tie and a couple of pins, including my Past National President Pin. Black slacks and patent leather heals were added to complete the ensemble. Janet would have been pleased!

16 September 2011 – Janet is escorted from the car to the Frontier gate where we departed for California.

The Young Marines provided a formal escort for me and Janet along with Carron Barrella, and Marge Alexander as we marched through the airport, through security, and to the gate.

There, an explanation of Janet's journey was given to the Young Marines. As I stood to enter the walkway to the plane, Janet's story was read over the loud speaker. I didn't expect that and tears flowed from the emotion when the applause and cheers came at the end of that reading. Then silence when the Young Marines saluted and I entered the walk to the plane. The crowd was in

awe of us carrying out such a valued tradition (mainly for active duty).

I SAT AT ATTENTION ON THE WAY TO CALIFORNIA. Several people came up to thank me for what I was doing and to ask about women in the Marine Corps and tell me their story of a son or daughter in the Corps. WMA was mentioned in each instance and a card given to them directing them to our web site.



At Orange County airport in CA, the procedure was reversed and a folded flag was added to the procession- A flag that was personal and had sentimental value to the leader of the Young Marines, Jack Closson. Folks in the airport took note and hands went over hearts as we passed. Thanks to Young Marines,

whose Unit name is LCpl Kenneth L. Worley Young Marines, Jack Closson is the Unit Commander. Participating were YMSSgt Samantha Rivas, YMPFC Oliver Feagin, YMLCpl Michael Hernandez and YMPvt Aaron Chadwick.

Thanks to Lt. Mike Miller and Special Officer Alan Kayano of the Orange County Sheriff's Department.

17 September 2011 – We attended a CA-8 meeting and explained the mission. I was honored that so many women came out to see me. One lady, Pauline



Buzan, in her 90's hadn't been to a meeting for many years, but came to see me! She will never know what an honor it was for me to meet her

and hear their many stories. These are wonderful women, as are each of our members-cherish them while you can!

20 September 2011-- Sybl, Helen and I arrived in Yosemite. In true Loyal Escort fashion, Helen drove the entire 300 miles! She and Sybl decorated the van with flags appropriately displayed for the occasion. We visited the main offices and asked for any last minute instructions. I'd previously obtained permission from the Department of the Interior, Park Superintendent, to spread the ashes and was given specific instructions about how to do that. It took some research, but we finally located the right individual who told us that as long as we followed those guidelines we could do it where ever we wanted.

We located a trail near El Capitan and

found a spot at least 100 yards from public view. Sybl and I saluted Janet and sang the Marines Hymn and March of the Women Marines (which you can hear by visiting www.WMACO1.org). I then proceeded to spread the ashes. When completed we gave a final salute and exited the park.



The Comcast Center

It is time to shake that Piggy bank and get ready for one of the best adventures of a lifetime! The WMA Convention will be landing in one of the most historic areas known to Marines! The birthplace of the Marine Corps is about to be invaded by the women Marines! There is so much to do and see in the city and the best part is that many of the venues are very inexpensive or free.

The tallest building is the Comcast Center at 975 feet tall. It is open to the public and also can boast about being the greenest building located in Philly. The building features a public plaza with a gorgeous fountain display, a dramatic eight-story "Winter Garden" and an energy-saving "glass curtain" that wraps around the Comcast Center, allowing for a 360° view of Philadelphia's urban landscape.

The Market at Comcast Center

Another one of the new building's main draws is its awesome selection of eateries. The Market at Comcast Center, located right below the building's main lobby, has more than 24,000 square feet of food retail and some 20 storefronts for your enjoyment.

Places like Bucks County Coffee Co., Di Bruno Bros., LaScala's, Mexican Post, Sook Hee's Produce, Susanna Foo's Dumpling Kitchen, Under the "C" gourmet seafood and Tokyo Sushi give you a wide variety of culinary tastes to try. The Comcast Center even has a picturesque outdoor café that is perfect for spring, summer and fall dining. Located immediately in front of the building's main entrance, the Plaza Cafe is a great place to stop by for a lunch, a light bite. drinks or dinner. A beautiful fountain display lines the seating area, while the fare comes from Table 31's exceptional kitchen. And the view looking up at the tallest building between New York and Chicago is pretty nice, too. So definitely add a visit to the Comcast Center to your "to-do" list during your stay in Philadelphia.

Hyatt Regency at Penn's Landing

Talk about a room with a view. The Hyatt is a great hotel that is the only hotel located directly on the Delaware River Waterfront. Here you can walk around the boardwalk, enjoy the riverfront, walk thru many of the close area

parks and enjoy the day as you please.

All of the rooms at the Hyatt were just completely renovated and now have only the finest that the Hyatt offers for sleeping and relaxing.

The area is full of things to do. On the weekends there are a variety of festivals only a block from the hotel. Fireworks were seen out our windows on the Saturday that we were there for the WMA Interim Board meeting and a free concert could be heard across the river in New Jersey.

Right next to the hotel is the Independence Seaport Museum. With historic vessels to board, a ship's hull to rivet, and cargo to unload with miniature cranes, Philadelphia's maritime museum conveys what the Delaware and Schuylkill Rivers have meant to the city over the years. Along with displays that chronicle the city's contributions to naval and commercial maritime history, there are exhibits about what makes boats float, the China trade and local small craft.

Berthed right outside are the Olympia, the nation's oldest floating steel warship (1892), most famous for being Admiral Dewey's flagship during his Spanish-American war victory in Manila Bay, and the Becuna, a classic World War II submarine that fought battles in the South Pacific. Workshop on the Water is a working boat shop where you can watch artisans build and restore traditional wooden boats.

The museum, dedicated to exploring the maritime history of the Delaware River, the Delaware Bay, and tributaries, opened on Philadelphia's waterfront in July 1995 after more than 35 years of rich history as the Philadelphia Maritime Museum. In 1996, the museum assumed responsibility for the Olympia and Becuna, which are both designated as National Historic Landmarks.

Sightseeing in Philly!

Philadelphia contains over 100 museums. If art is your interest, then you'll want to visit the Philadelphia Art Museum. It is located on the Ben Franklin Parkway. This is where Sylvester Stallone, in the film "Rocky" jogged up the museum steps in record time! The museum showcases paintings, furniture and pottery from the Pre-Christian Era to modern time. It even has a Japanese Tearoom that was disassembled in Japan and brought to Philadelphia. Touring the museum can be exhausting, so plan to spend the whole day. The regular admission price is \$8.00, but if you go on Sundays before 1 p.m. the admission is FREE.

There are many cultural museums to tour, but two of the most interesting are The African American Museum and The National Museum of Jewish History. The African American Museum is located at the NW corner of 7th and Arch Streets. This marvelous museum showcases folk art, artifacts, and often has musical attractions. The admission is \$6.00. The National Museum of Jewish History is located at 55 North 5th Street. The museum exhibits historical documents, artwork, films, and personal memorabilia. This fascinating attraction has an admission price of just \$2.50.

One of the most bizarre attractions and certainly not for the faint hearted is the Mutter Museum. The Mutter Museum is operated by the College of Physicians of Philadelphia. The museum is a strange collection of medical oddities. It exhibits skeletons of Siamese twins, preserved bizarre shaped tumors, and collections of primitive medical instruments. The Mutter Museum is a must see; you'll never forget it. Admission price is \$8.00 and located at 19th South 22nd Street.

Equally as strange, but less gory is the Eastern State Penitentiary. The penitentiary was an operating prison between 1829-1971 and housed some of the most notorious criminals including Al Capone. The penitentiary offers a display of prison artifacts, an exhibit of death row, and guided tours. An odd site, but truly a remarkable piece of history. The penitentiary is located at 22nd and Fairmount Streets. **Admission is \$7.00**.

Philadelphia's historical district is phenomenally beautiful, restored and well kept. You'll want to stroll along the streets of the Olde City and take in the splendor of the old world charm. Most of the old brownstones and cottages of the early settlers still remain. One fascinating way of seeing many of these glorified old homes is to take the Tour of Historic Haunted Philadelphia.

The tour takes about 2 hours, and you will get to see at least half-a-dozen infamous haunted homes. The homes are some of the oldest in Philadelphia, ranging from tiny cottages to ostentatious mansions. The ghost stories are both eerie and amazing as much as they are a great way to learn about the history of Philadelphia's earliest citizens. The tour costs \$10.00, and tickets can be purchased at a neighboring restaurant at 6th and Chestnut, called Willie & Duffy's. This tour is simply a must do! Although not on the tour, you'll want to visit the nearby former home of Edgar Allan Poe. The home is located at 532 N. 7th Street. Mr. Poe lived in this home between 1838- 1844. He wrote The Raven while in residence there. The Poe family owned and rented several homes in the Philadelphia area, but the 7th Street site was the only one in which Mr. Poe personally resided. The home was in disrepair for many years,

but has been rescued and restored by the Philadelphia Historical Society. Many of Poe's personal papers and original drafts are on display at the home. Admission is FREE!

Although New Jersey is known as the Garden State, Philadelphians can't figure out why that is since Philadelphia is a gardener's paradise! Fairmount Park is one of the largest parks in the United States. It begins in Philadelphia Museum of Art area and continues to the Montgomery County line. It's circumference is approximately 28 miles.

The park contains plentiful wildlife, and bird watching is an avid sport. Within the park there are various sites such as war memorials, nature centers, fountains, picnic areas, concert halls, and mansions. One of these magnificent mansions is the Ebenezer Maxwell House. It is a splendid example of Philadelphia's high society Victorian life. It is located at 200 W. Tuplehocken Street.

The gardens at the Maxwell house draw enthusiasts from all over the county.

Fairmount Park also contains dozens of hiking trails, and since the park borders on the Schuylkill River, boating and canoeing are favorite sports. Along the Kelly Drive side of the park, one can rollerblade and bike ride. At the far north end of Fairmount Park the Morris Arboretum is located. The arboretum is maintained and funded by the University of Pennsylvania, and it is breathtaking. There are over 2,000 types of plants from all over the world. There is also a collection of rare trees that is a must see! Guided tours are available as well as a self-guided tour. The arboretum is located at the corner of Germantown and Northwestern Avenues and the admission is \$6.00.

Did you know that you now have a choice in the format of the Resource Manual and Directory (RM&D) you can receive? We are now offering the option of receiving the RM&D in the current hard copy format or now on a CD or in electronic form. This effort of reducing the number of hard copies of the Resource Manual and Directory (RM&D) beginning with the 2012-2014 issue that will be published after next year's convention, along with offering 'Nouncements in an electronic version, is based on a decision made at the national level to help reduce our budget deficit. For your information, it costs about \$20,000 to publish and distribute the RM&D every two years and about \$25,000 a year for the (4) quarter-

ly issues of 'Nouncements. Many other organizations are going to this same type of distribution format including the Marine Corps Association who now publishes/distributes the Marine Corps Gazette and Leatherneck magazines both in hard copy and electronic format.

If you look in your most recent copy of the 2010-2012 RM&D you

will see several references to this plan including page 2 in the Letter from the IPP, pages 10, 23 (on the membership application), 25 and 26 and finally on page (127) there is a detachable form that you can tear off and send in to identify your preferred format.

In addition, if members are willing to make a donation to help offset the cost of these publications, that will help tremendously. This information reminder will be published in the upcoming issues of '*Nouncements*, on Facebook and through your Area Directors.

We have a full year to work on this project but it will take your participation to get it done.

If we can reduce the number of hard copies and provide the publications in either the CD or Electronic format, we can save a lot of money. I appreciate your support in this effort to assist WMA to maintain its fiscal responsibilities and demonstrate your individual involvement in continuing to make WMA the professional veteran's organization that it is.




LA-1 Members Attend NOMMA Meeting

New 'HOT' Women Marines Chapter Fired Up

When Cpl. Barron, now Huber, was inspecting aircraft and ensuring they were ready to take to the skies over Camp Pendleton, Calif., in 1990, the Aviation Structural Mechanic didn't know she'd be in Austin, Texas 20 years later leading a different group of Marines.



Cyla Huber, 44, of Seattle, is the president of one of the newest Women Marines Association chapters. The WMA "Heart of Texas" Chapter 5 was es-

tablished earlier this year, and they're calling Austin home. Huber recognized there was a need for a Women Marine's chapter in this part of Texas.

"The closest chapter was in San Antonio, and I felt there wasn't a chapter bridging the gap in the distance between Dallas and San Antonio," she said.

Being the leader the Corps taught her to be, she got in touch with Maria Elena Perez Crowley, the area director for the Texas WMA chapters, and voiced her concern for a chapter in the Austin area. Crowley agreed with her.

"I knew that a chapter was needed for the Austin area, and as Area Director, I was more than happy to get involved," Crowley said.

Huber got the ball rolling and the new chapter started coming together quickly. After a few more gatherings over the span of a couple months, 14 members were present and accounted for.

In June the chapter, who likes to be referred to as "HOT" TX-5, made Austin's VFW Post 4443 their official meeting place. The members came together with the desire for the camaraderie they once enjoyed in the Marine Corps.

Member Cathleen Gruetzner, historian and vice president for "HOT" TX-5, said she "wanted the chance to work with other Marines and have a sense of family again."

Becky Brewington, who's treasurer for the Chapter, saw an opportunity to serve her community and also be a part of the Marines again.

"I've been wanting to be involved in community service and being part of what makes Austin great," Brewington says, "I also love to be part of representing the professionalism and esprit de corps of the USMC."



"HOT" TX-5 has been busy since its formation, including winning "Most Patriotic" for their entry in the Round Rock Fourth of July Parade this year.

"Winning the award was a surprise," said chapter president Huber. "I was so proud of the women for their work on our entry."

Their showing at the Round Rock parade also brought the chapter coverage in the *Austin American Statesman*.

"There was Cathleen Gruetzner of the Women Marines Association, shouting at the crowd, with irrepressible optimism, "It's a semper fi day! Oo-rah!" and getting the crowd to shout it back," read the article in the *Statesman*.

Gruetzner's motivation had her busy



prior to this parade, too. She was presented the "Most Original Overall Entry" award at the Lexington Parade in Lexington, Texas April 30.

"I am pleased that the Women Marines Association is getting attention and that other female Marines are learning about us through the media," said Gruetzner.

Huber is also motivated in recalling where the group has come and where they are headed.



"I'm very impressed by the diverse group of women Marines that have all worked to put together our chapter," she said. "Progress has in a lot of ways went very fast considering we only started out with 5 members and now have 14 after only six meetings, two of which were social/community events. We have accomplished a lot considering we have limited resources."



But, Huber and her fellow "Heart of Texas" Marines won't let limited resources stop them from accomplishing their mission.

"Like Marines we are doing a lot with a little," she added.

The chapter

is continuing to reach out to find new members on their facebook page and their website, <u>www.txwomenmarines.</u> org.

The Marines of "HOT" TX-5 have big plans for the future. Their official charter was presented to Crowley by the WMA national secretary Joan Cordero in August and their installation meeting is scheduled for Oct. 2nd. The group also plans on entering in the Austin Veteran's Day Parade, they want to support the local Toys for Tots drive during the holidays, they plan on furthering their relationship with Austin's VFW Post 4443. Above all they're eager to expand their presence and service in the Austin area community.

Chapter Tool Kit: Results of WMA Chapter Survey

During the Denver 2010 WMA Convention, the Area Directors were tasked with determining the strength of the chapters within their areas. At the 2011 WMA IBM in Philadelphia, the results of the Chapter Surveys were presented. There was some interest in the results of the survey by the chapters and I want to share the information here.

The surveys covered many areas of chapter responsibility including number of members, meeting frequency, officer status, meeting minutes, chapter finances, chapter audits, chapter IRS status, dues status with national and the chapter and chapter life memberships. With approximately 77 chapters in WMA, 53 chapters participated in the survey.

Chapter membership is as high as 100 and as low as two, with the average being 24. The high chapter attendance is 27 and low chapter attendance is 2, with the average attendance at meetings is 9.

Members physically unable to attend were from 0 to 20 with the chapters averaging 7. The chapters meet 2 to 12 times each year with the average being 4.8 meetings each year. Seventeen chapters do not have a full slate of officers. Twenty-one chapters have at least one officer who does not use email. Fifteen chapters have officers who do not attend meetings. Sixteen chapters do not have two officers with signature authority on all active accounts. Twenty-two chapters conduct audits of chapter finances. FL-7 has had the same treasurer for 23 years. Annual dues range from \$2.50 - \$20.00 each year, with average dues being \$9.50. Fifteen chapters offer life membership in their chapters.

Recognized chapters include MA-1,

DC-1, IL-2, LA-1 and CA-7; these chapters are large, active and in compliance with WMA procedures. Thirty-five active chapters were identified with active membership, officer rolls filled and compliant with WMA procedures. Nine chapters were identified as marginal. Four chapters are identified as inactive and do not meet the following: officer support, not enough members, do not meet chapter meeting requirements, and/ or do not comply with WMA procedures.

The surveys provided valuable information about the WMA chapters. The Area Directors and chapters worked together to collect the information and submit it in a timely manner; many thanks to all who participated in the surveys.






