The new WMA Veterans Affairs Voluntary Service (VAVS) National Representative, Kay Croll, is on the job and leading the way for our volunteers. Welcome aboard Kay. We are all looking forward to a renewed commitment to the VAVS Program.

Many of our veterans are moving to areas where they do not have a chapter and they take a look around and discover, "hey, there are enough WMA members here to support a chapter." Or, perhaps, it is a member of an active chapter, who, relocates, and still wants to be part of a chapter, who gets the

ball rolling. Growing new chapters is revitalizing for all organizations. When that is approved, the chapter will dispose of the chapter assets as directed in the WMA Bylaws.

WMA is proud of all the 78 chapters in the organization. Many of them are early chapters from the sixties that have been active with WMA and in their local communities. The strength of our organization is not just measured in chapter size, but in the commitment of our members. As our new chapters come on board, we may see other chapters retire with pride, knowing the "sword has been passed." For all of our members who don't have the opportunity to belong to a chapter, I encourage you to find or form a chapter. Being part of a WMA chapter is important because we are known by the company we keep. We all grow in this association with women who earned the title Marine.

#### **Arizona Honors**

On October 30, Bettie Lerdall, June Dempsey and I went to a luncheon honoring 19 veterans from Arizona who have contributed to the community since leaving the service. Our own Joan Sisco, president and CEO of Veteran's First Limited, and member of AZ-1, was one of those inductees.

Joan's citation read, in part: "Since establishing Veteran's First Limited, Joan's work enhances the lives of veterans and their families. She serves as the Arizona coordinator for homeless and women veterans. She is a member of many local veterans' organizations, state, and VA committees."

Joan is currently working on a complex of efficiency apartments for homeless women veterans. Established by a grant from the state, Joan works tirelessly in getting donations to furnish these apartments with new items for the women. It is hoped that the first tenants will be accepted late in November or December. AZ-1 has donated \$1,000.00 to furnish one of these apartments.

While at the luncheon, I met LtCol Sally Carroll, former woman Marine, now retired Army. Sally was stationed at Cherry Point when I was during the late 50's. Also in attendance was Lee Borgen, AZ VA Service Officer from Lake Havasu, AZ. Joining us at our table was Air Force Senior Master Sergeant Bonnie Krentler, who retired on 31 October 2009. Her mother was a WR in WWII. In the photo, June Dempsey, Bettie Lerdall, myself and Joan



are with Miss Arizona. Her cousin is a Marine and was so thrilled to meet three former women Marines that she wanted a photo to send to him.

#### **Carolina Canines: Service Dogs for Wounded Veterans**

Carolina Canines for Veterans is a national pilot program that teaches prisoners at the Camp Lejeune brig to train service dogs for wounded veterans. Launched in 2008, the program operates entirely on private donations. Carolina Canines for Service (CCFS) trains the prisoners to raise and train each service dog.

A Carolina Canines service dog is a constant companion that can perform more than 70 tasks for the wounded veteran, including:

• Retrieve and carry objects

- Pull their partner in a wheelchair, push elevator buttons and even transfer money at the grocery store.
- Provide social support by acting as a bridge to conversation and acceptance. When a service dog accompanies a wounded veteran, the focus is on the dog, not the disability.
- Provide balance and stability for an amputee or someone who has lost mobility.
- Be a source of love and companionship.
   Both the veteran and the dog are a team and make the transition back to independence together.

Wounded Warrior Cpl. Chris Gray was the recipient of Rocio on October 17, 2008 at a ceremony and reception at the Marine Corps Base Camp Lejeune for the first placement from the Carolina Canines for Veterans program. Cpl. Gray was injured in Iraq in February 2007 when two rocket propelled grenades struck the tank he was in igniting the bulk of

ammunition and causing an explosion. Gray suffered severe burns along with the tank commander. Because of these injuries, Cpl. Gray is not able to do everyday tasks which once were simple for him. Rocio, a Labrador Retriever mix, was trained by prisoners to assist Cpl. Gray with his needs. The dog came from Southport Oak Island Animal Shelter, a local non-kill facility in Southport, NC,

after passing a rigorous temperament and health screen by Carolina Canines staff. Rocio was in training for 10 months.

Just what does it take to run a program like Carolina Canines for Veterans?

- Over 150 dogs were initially screened
- Over 50 dogs were evaluated for temperament and working aptitude
- 30 dogs had hip evaluations by radiographs at local veterinarian offices to select the dogs in the program.
- 1600 pounds of dog food and 400 pounds of high level treats consumed
- · 3200 waste bags used
- Prisoners worked over 11,000 hours training the dogs
- Volunteer trainer, Stephen LeQuire has given over 1200 hours of time
- Staff has spent over 858 hours
- Travel time to and from Camp Lejeune is just over 350 hours

The service dogs trained in the Carolina Canines for Veterans program will only be provided to veterans. There is no government or military funding for the program and based on discussions with

Congressman Walter Jones (NC-3), the appropriations committee would not even consider funding until 2012. With the needs of our veterans, waiting an additional four years to begin a program to benefit them is too long. All program costs including veterinary care, dog food, training equipment and instructional material, adaptive

equipment (e.g. harnesses) and team training are the responsibility of Carolina Canines for Service.

### WMA Dues to Change

The WMA Bylaws Article 10 states that the Board can change the dues with a 2/3 majority vote taking into account "the limited resources of some of our members, the needs of the Association, and the value members receive from their membership. [Also,] at least 6 months advance notice must be published to the members before the effective date of any change in dues." At the Interim Board Meeting in October in Kansas City, your Board decided it is time to make a change.

WMA's dues have remained at the same level for 19 years. Our national dues are far below most veterans organizations and minimize the value of our membership. And the current dues (amounts shown on the membership application on the back of this newsletter) barely keep up with even basic expenses for each member: the annual cost of printing and mailing 'Nouncements and the prorated cost for the Resource Manual & Directory is approximately \$9.50 per member per year; the cost to maintain our data base and provide other member/treasurer assistance is \$3.20 per member per year.

The following policies were decided on by the Board at the Interim Board Meeting:

- The one-year membership amount is of limited value to our members and to the organization. If we delete it, members won't have to send in renewals every year and the Association won't have to spend funds on post card renewal notices as often.
- Even though Life Membership is not economical for the organization, we should maintain the option for Life Memberships as a convenience to our members (and to keep some on the rolls who would "forget" to renew). Note that the Bylaws allow for payment

in 3 installments. The amounts should be raised, however. Also, by having more age breakdowns, we offer members the opportunity to shift to Life Member dues quicker (i.e. they won't have to wait for several more birthdays to get the lower rate).

• WMA should continue to shift \$50 for each newly deceased life member into the Memorial Scholarship Fund, in memory of that member.

The Board has approved the following **changes to be effective** 1 July 2010:

- That the annual dues option be deleted.
- That the biennial (2 year) dues be raised (from \$25) to \$40.
- That more breakdowns and higher amounts for Life Membership Dues be defined:

Age 30 & Under \$295	
31-39	\$260
40-49	\$210
50-59	\$180
60-65	\$150
66 & older	\$120

Important: You have 6 months to get your dues paid at the current lower rate if you send your renewal or change to Life Membership with your (first, if paying in installments) payment to arrive before 1 July 2010. And you can pay ahead as many years as you'd like!

If you have a computer, you can now get your DD-214 Online. The National Personnel Records Center (NPRC) has provided the following website for veterans to gain access to their DD-214's online at: http://vetrecs.archives.gov/

NPRC is working to make it easier for veterans with computers and Internet access to obtain copies of documents from their military files. Military veterans and the next of kin of deceased former military members may now use a new on-line military personnel records system to request documents. Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the on-line web site. Because the requester will be asked to supply all information essential for NPRC to process the request, delays that normally occur when NPRC has to ask veterans for additional information will be minimized. The new web-based application was designed to provide better service on these requests by eliminating the records centers mailroom and processing time.

Under a new regulation effective June 15, VA will enroll veterans whose income exceeds current means-tested thresholds by up to 10 percent. These veterans were excluded from VA health care enrollment when income limits were imposed in 2003 on veterans with no service-connected disabilities or other special eligibility for care. There is no income limit for veterans

with compensable service- connected disabilities or for veterans being seen for their service-connected disabilities.

Veterans who have applied for VA health care but were rejected due to income at any point in 2009 will have their applications reconsidered under the new income threshold formula. Those who applied before 2009, but were rejected due to income, must reapply. VA will contact these veterans through a direct-mail campaign, veterans' service organizations, and a national and regional marketing campaign.

Information about enrollment and an income and assets calculator are available at www.va.gov/healtheligibility. The calculator provides a format in which veterans enter their household income, number of dependents, and zip codes to see if they may qualify for VA health care enrollment.

In addition to applying online, veterans may also contact VA's Health Benefits Service Center at 1-877-222-VETS (1-877-222-8387). Each VA medical center across the country has an enrollment coordinator available to provide veterans with enrollment and eligibility information.





CA-15 wants everyone to know about our new member, Lupe Sara Omari. At our request, she wrote her autobiography, and here it is.



Sara Omari of CA-15.

"My name is Sara Omari. When I was in the Maine Corps, my name was Lupe Rivas. I was born in the early 1930's in the state of Texas.

"My grandparents came from the Great Apache Stronghold at Ramos-Arizpe in northern Mexico, though my people at that time had no real borders between their lands.

"I am of the Mescalero Tribe, which is a member of the Great Apache Nation. We are a matri-

archal society, and my grandmother was in charge. She was the one I listened to, and it was she who told us we had to assimilate to survive. She taught us to remember who we were as members of the Great Apache Nation and of the great warriors of our nation, including Geronimo, Cochise, Mangas Coloradas, Nama and Victoriano. My grandmother told stories of the missions and the forced labor associated with them.

"My people worshiped the Great Spirit, but foreigners forced Christianity upon us just as they forced English, Spanish, and the Franco-Germanic language of the Alsace Lorraine Province.

"Most months we held a powwow gathering. Strangers were a no-no. Our people behaved differently, and our ways were not for outsiders to know.

"I have many vivid memories of my childhood. One of my favorite meals was turtle soup, which my grandmother prepared. One day I learned that the delicious soup we'd enjoyed had been made with a turtle I often played with.

"We did not have candy, but I can easily recall eating honeysuckle blossoms for their sweet nectar.

"The males among us had to go though a rite of passage, which entailed a night alone in the woods sleeping in trees to avoid animal and human predators.

"Every year, just like squirrels, we'd gather pecans. The men would shake the trees and the women and girls (who, for reasons of modesty, were not allowed to be up on ladders) would gather the pecans as they fell. We'd then store them for the winter and have a celebration of the gathering. We also celebrated the harvest season with an autumn festival, which was a time for giving thanks.

"We washed our clothing in the river and hung the wet clothes on bushes or laid them on rocks to dry. Water had to be carried from a water source or noria (water well).

"There were sometimes raids between our warriors and foreigners. When the warriors returned from battle, there would always be a celebration. If a warrior was extra nice when he returned, I knew it meant he had been extra cruel outside.

"I entered Marine Corps boot camp Jan. 8, 1954, and graduated March 11. I was stationed at Camp Pendleton and worked first as a clerk and then as a buyer. I later became a cash buyer for base purchasing at Pendleton.

"Many in my family have served in the military. One of my uncles lies at the bottom of the USS Arizona. Another uncle was on the USS Lexington. Blood cousins who have served in the Marine Corps were Andrew, John Jess, Geronimo (Jerry) Rivas, and Dwayne Locker, my nephew. My son was in the Devil Pups. My brother Abe was in the Air Force during the Vietnam War. My nephew Eddie served on the USS Nimitz, and my grandnephew Zack served in the US Army.

"In June 1954, while being transferred from Parris Island to Camp Pendleton, I met Ira Hayes. I had just read the history of the Marine Corps, so it was quite an honor to meet him. He was a Pima.

"In boot camp, I trained with a Sioux, Arlene Ardmore, and a Navajo, Agnes Peters.

"I learned a great deal in the Marine Corps and have a lot of memories of good friends. While I'd been well taught by my grandmother, the virtues of punctuality, respect, responsibility, and correctness were reinforced in the Marine Corps".

### **Chapter Tool Kit: Chapter Money Management**

As we review the tools we can use to make our chapters stronger, it is very important to ensure the chapter follows good money management. The chapter funds are the property of the chapter, with the chapter President and Treasurer designated as the responsible officers. This means that all accounts belonging to the chapter should have signature cards for both officers on file with all financial institutions. In addition, the Treasurer will provide a record for all accounts to the President along with regular written reports for the chapter meetings and chapter minutes.

After each chapter Installation, the newly installed President will ensure that an audit of the chapter accounts is conducted. The auditors can be a committee of responsible chapter members appointed by the Presi-

dent. The auditors will provide a written report at the next chapter meeting. Reports from the Treasurer should be provided at each business meeting. All expenditures must be approved by the chapter board.

## Taking care of chapter funds does not require a CPA, but it does need common sense.

The Treasurer is charged with paying all authorized bills, keeping accurate accounts and presenting sound financial statements at each business meeting. It is imperative that chapter Treasurers protect their chapters from outside criticism by performing their duties with honesty and accountability. The Treasurer needs to keep the chapter

president and members fully informed of all business conducted for the chapter.

I would like to caution all of our chapters to ensure the care of chapter funds. Taking care of chapter funds does not require a CPA, but it does need common sense. Never have a chapter account with only one chapter representative as the responsible officer; this protects the chapter, the President and the Treasurer. If an officer is replaced, changing signature cards should be a priority. Remember, it is unacceptable to have chapter funds in a personal bank account.
