
MI-2 members gathered together for an attempt at a Guinness World Record.

I often receive e-mails from members asking how they should submit a Chapter Clipping, or an article to *Nouncements*. A few months ago, someone asked if I could publish guidelines of what is expected for each submission. You will find the rules for submission below.

*All* submissions to WMA *'Nouncements* are welcomed. We encourage you to keep us informed of noteworthy activities you or your chapter have accomplished. <u>FORMAT:</u> Please e-mail your contributions as Word files whenever possible, and send us your best photos as JPEG attachments. You may also type your submission in the body of the e-mail. Please do not embed your images in Word documents and send the actual size photo. There is no need to shrink it. If you do not have computer access, you can mail your clipping via the post office. It does not need to be typed, and if you are sending photos, please send copies of the originals—not photocopies. Photos will be mailed back to you.

### REMEMBER THE FIVE W's :

In preparing your stories, remember to include: <u>WHO:</u> Name the people involved. Include any ranks or titles.If you meet or interview somebody, please tell us their name. Make sure names are spelled correctly! <u>WHAT</u>: What was the activity? Was it a memorial ceremony, a fundraising event, or a parade?

<u>WHERE:</u> Be sure to tell us where the activity occurred. Not only the city, but be sure to tell us the name of the event, park or building. Give us the full official name if possible.

<u>WHEN:</u> Tell us when the activity took place. Weekday? Weekend? Morning? Evening? The exact date? <u>WHY:</u> Tell us why your chapter participated in this activity, and of any personal connections to the event. ALSO: Remember to take a minute to check the facts of your story.

Please remember that due to space limitations, we usually do not print more than two articles from the same chapter. When a number of members from one chapter send in articles on the same theme or event, we will combine their accounts.

Remember, too, that this is a great opportunity to tell your fellow Marines (as well as the general public) of what you enjoy most about being involved with our association.

# From the 1st Vice President: Let's Get Back To Our Roots

I would like to address a topic dear to my heart. Specifically, when WMA was first formed, one of our key purposes was to look after and take care of our sister Marines. This is something we seem to have gotten away from over time. I realize that we all have busy lives, but most of these



suggestions don't involve much time. Unfortunately, we have many members who are no longer young and they can't get around as well as they did before. Many of our older members have no e-mail capabilities, so they cannot enjoy the constant flow of information that many of our younger members utilize to keep in touch and informed.

Many of our senior members have no children and have outlived many, if not all, of their family members. Others live in areas where there are no family members nearby, and they are basically alone. In such cases, WMA can be more than an organization to which they belong; it can be their Marine family. Quite a few of our members currently reside in senior living facilities, assisted living facilities, veteran's homes or live alone depending on their physical and/or mental limitations.

What I would like to suggest is that our chapters each start a project to provide one or more of the following services for their sister Marines. Here are some suggestions concerning local members who live alone or in some kind of care facility:

1 - Visit confined members as often as possible

2 - Send cheery cards monthly, quarterly, or on major holidays

**3** - Call older members at least once a month to see how they are doing

4 - For members who can't get around, offer them a ride to chapter meetings

5 - Visit older chapter members who are hospitalized 6 - Find out older members' birthdays and send birthday cards to make their day more special

You might ask how you can locate such members. The best place to start is with the quarterly rosters that National provides to each chapter. Not only do those rosters list all the members of your chapter, they also give you a roster of all the Members at Large (MALs) who live in your area. By searching the MAL roster, you can find members whose address is a care facility or VA facility. You can call some of the MALs in your area to see if they need or want calls or visits. Ask your chapter members if they know any women Marines who live in your area and could use a card, call or visit from their sister Marines.

Another possibility is to draft a letter about your chapter and send it to all the MALs within easy driving distance to see if they would like to attend your chapter meetings or special events. Offer to provide transportation if possible. This could get new members for your chapter and it would give the older members something to look forward to when your chapter meets. I am sure that many of you have other brilliant ideas to help to brighten someone's day. Send them to me and I will share them with our members. One of the greatest things about our older members is that it takes very little to make them happy. Just a smile, a cheery greeting or a few minutes of your time can work miracles for someone who spends most of their time alone. The most important thing you actually give them is the knowledge that someone cares, that they do matter and that Marines always take care of their own.

It was seventy-two years ago that the Marine Corps Women's Reserve was created, proving--yet again—that women were a necessary component to pur Nation's security and freedom. As I meet our wonderful Women Marines Association (WMA) members, I am reminded that forty-six percent of our members are over the age of 70 (as referenced in our WMA 2013 Resource Manual and Directory-RM&D); they've seen the Marine Corps transition into the power force it is today. 
As we reflect on 1943, it is important to be knowledgeable about our WMA history. It was seventeen years later that our WMA founders held a reunion in 1960. Our Historian/Curator of the Women of the Corps Collection, Nancy Wilt reminds us of the following:

"We need to pause at this time and recognize Major Jean Durfee, USMCR(W) whose idea for a National Organization of WWII women Marines became the Women Marines Association. Major Durfee, as early as 1957, conceived the idea, created the plans of organization, instituted the development of a data listing 8,000 plus names of WWII women USMCR(W) members, organized the first National Reunion in Denver and chaired the event. Jean Durfee retired from the Reserves and is now looking down on how her idea and guidance made WMA a reality".

Let us also remember our other past leaders, whose talents have shaped WMA, such as Genevieve M. Dooner, the first National President of WMA, then, Helen Hannah Campbell, Helen E. Moore, Olga C. Bullock, Ruth Hammond Broe, and our Theresa "Sue" Malone Sousa (who I still affectionately refer to as Founding Mother). When we reflect on our past, it is a marvel at how these early WMA leaders crafted out guidelines, traditions and friendships that remain in our every vein today. It is now up to us to continue to valiantly carry the torch today, to create an even better tomorrow.

Our latest generations of Marines need us...our wisdom, our experience, and our vision. I call on you to sponsor a sister Marine Veteran in your communities, invite a newly transitioned Marine to your Chapter meetings, reach out to a Member-at-Large to let her know that you are there (if ever needed). Our founders created WMA because they knew how special our bond is and how much more we can do when we work together, as Sister Marines. Yes, we work hard to give back in scholarships and community service, but, we play hard celebrating our esprit de corps.

As we acknowledge the 72<sup>nd</sup> anniversary of the continuous service of women in the Marine Corps, let us remember our WMA Past Presidents, who gave their talents to further our cause. Every chance you get, say "thank you" for leading this illustrious Association. We are women by gender, Marines for life!!

# VA Eliminates Net Worth as Health Care Eligibility Factor

(Washington) – The Department of Veterans Affairs is updating the way it determines eligibility for VA health care, a change that will result in more Veterans having access to the health care benefits they've earned and deserve.

Effective 2015, VA eliminated the use of net worth as a

determining factor for both health care programs and copayment responsibilities. This change makes VA health care benefits more accessible to lowerincome Veterans and brings VA policies in line with Secretary Robert A. McDonald's MyVA initiative which reorients VA around Veterans' needs.

"Everything that we do and every decision we make has to be focused on the Veterans we serve," said VA Secretary Robert A. McDonald. "We are

working every day to earn their trust. Changing the way we determine eligibility to make the process easier for Veterans is part of our promise to our Veterans."

Instead of combining the sum of Veterans' income with their assets to determine eligibility for medical care and copayment obligations, VA will now only consider a Veteran's gross household income and deductible expenses from the previous year. Elimination of the consideration of net worth for VA health care enrollment means that certain lower-income, non-service-connected Veterans will have less outof- pocket costs. Over a 5-year period, it is estimated that 190,000 Veterans will become eligible for reduced costs of

their health care services.

In March 2014, VA eliminated the annual requirement for updated financial information. VA now uses information from the Internal Revenue Service and Social Security Administration to automatically match individual Veterans' income information which reduces the burden on Veterans to keep their healthcare eligibility up to date. That change better aligned VA's health care financial assessment

program with other federal health care organizations.

Veterans may submit updated income information at www.1010ez.med.va.gov/, or by visiting their nearby VA health care facility. For more information, visit www. va.gov/healthbenefits or call VA toll-free at 1-877-222-VETS (8387).

# Loyal Escorts: Some Computer Safety Tips



Sometimes you may receive an E-mail that appears to be from someone you know. It's best to avoid clicking on links contained in an e-mail, unless you are actually expecting it.

However, an e-mail from someone you know with a short message stating they have a secure document for you to review (too general), would be suspicious, especially if you haven't had any conversations related to secure communications.

Here are some tips from Norton for handling e-mail, both using a WMA e-mail, as well as personal e-mail.

How They Attack	How You Know	What to Do

Phishing	<ul> <li>Requests for confidential information via email are not legitimate.</li> <li>Phishing attacks may use scare tactics to entice a response.</li> <li>Fraudulent emails are very often not personalized.</li> <li>Phishing attacks may consist of a group of e-mails that share similar properties, like details in the header and footer.</li> </ul>	<ul> <li>Be extremely wary of e-mails asking for confidential information.</li> <li>Confirm the authenticity of a suspicious request before responding in e-mail.</li> </ul>



# **Our History Continues to Grow**

#### • Educators Series Presentation at the National Museum of the Marine Corps (NMMC)

I was honored to represent WMA at a women Marine history presentation at the NMMC the first week of December, as visiting instructor. The presentation fulfilled a request received by the NMMC Teacher in Residence, from the attendees of this year's Educators Series on Marine history. The attendees' request was for the addition of an entire evening program on the history of women Marines. This 3.5 hour presentation included leading a tour of existing women exhibits at the NMMC, followed by a classroom presentation of our history from Marine Corps Legend "Lucy Brewer", through our women serving today.

The class was hugely popular with the educators participating and provided the NMMC Education Department staff with much needed information and history they did not have available on women Marines. My participation in this unique and important program was made possible by WMA.

The trip to Washington was made even more special by meeting for dinner with WMA's, Sue Sousa and Eileen Scanlon right after my arrival. A delightful evening with a "wonderful touch "of WMA history stories added to our dinner.

Using every minute of my trip, my schedule, allowed me to interface, I was able to meet with historians from History Division HQMC and to meet with Colonel Mary Reinwald, USMC (Retired), the new editor of Leatherneck Magazine. Prior to the NMMC event, I had the opportunity for a visit with LtGen. Robert Blackman, USMC (retired), President and CEO of the Marine Corps Heritage Foundation that supports the NMMC. Prior to departing for Denver, I met with Mary Karcher, a writer, who for *Leatherneck* Magazine has covered multiple WMA Conventions and is a huge WMA supporter.

• The Loss of a United States Marine WMA, Women Marine history and the "Women of the Corps Collection" have lost a *very* special Marine with the recent passing of Mary Bacon Hale. Mary, a proud WWII Marine, was for decades an active WMA member. She was responsible for starting numerous (8-10) California chapters while being the Area 10 Director. Mary then moved to the position of WMA Plans and Policies Officer.

Mary's dedication to the preservation of the history of Women Marines led her to:

• Develop the concept for the 3 White (WMA) History and pictorial history books, some of the first non-Marine published books on the history of women Marines.

• Mary then led the process of gathering the personal stories of hundreds upon hundreds of women needed to fill 3 books, editing and researching, as needed the material received.

Mary then located and worked on the book development with Turner Publishing while funding the search for the stories, mailings, administrative and printing costs, for the books.

The president of Turner Publishing gave Mary Bacon Hale the title of "Honorary Turner Editor" based on her editing and administrative skills in handling such a major project.

• When the idea for the then "History Project" was originally presented at one of WMA's Interim Board meetings, Mary responded to my presentation by handing me a check for \$10,000 dollars to start with as "seed money" for the project.

That check has been followed by many others over the last decade, and has led to the Women of the Corps Collection developing into the largest known collection of WM history and memorabilia that continues at a dramatic growth rate today.

While the WOCC was still a chapter project, Mary Hale, with other donors and potential donors, requested that for their continued support, a separate 501(c)(3) foundation be formed that would have but one function: to financially support the Women of the Corps Collection (WOCC). Their request was made to ensure their gifts be utilized for the sole purpose of funding the WOCC.

With guidance from then Marine Corps Heritage Foundation CEO, Lt-Gen Ron Christmas, members of the MCHF Board, General Hagee, CEO of the Nimitz Foundation and expert legal counsel the Women of the Corps Foundation, (WCF) a 501(c)(3) foundation, became a reality. Since the WCF's creation, it has provided 100 percent of the WOCC's Operating funds.

*Note:* WMA, through the Memorandum of Agreement with the WCF, the WOCC remains a WMA entity but does not supply the Women of the Corps Collection with any of operational funding that being the function of the WCF.

Funds that have been donated through WMA and clearly marked for the WOCC are being held as a special project fund for the WOCC at their request. One such special project is in the development phase at this time.

Mary's dedication to the preservation of history did not end with WMA.

Mary is considered a major donor by the National Museum of the Marine Corps and her name appears in the main lobby on the major donors wall of the NMMC.

WIMSA and the Women's Memorial were also recipients of Mary's generosity in funding military women's history. From the earliest calls for support by General Vaught when WIMSA and the opening Women's Memorial were just dreams, until recent times, Mary Bacon Hale answered the call for assistance.

Mary Bacon Hale dedicated a major portion of her life and resources to the preservation of women Marines history, and the welfare of *(Continued)*  of women Marines in need, so please help the Women of the Corps Collection continue her efforts.

#### • The Veterans Speak Exhibit

Veterans Day and veterans were celebrated by the city of Boulder, CO for two and a half weeks in November. The WOCC and the Broomfield Veterans Museum created military exhibits.

Each day started with a "Veteran coffee" with military speakers from different generations, followed by talks and guided tours of the exhibits offered from 8:00 am to 6:00 pm daily. Each evening closed with a different famous war movie at a WWII-era price. Veteran art filled the rooms and meeting areas. Sunday was the volunteers' one day of rest.

As Historian/Curator of the WOCC, the exhibit and I moved to Boulder for nearly three weeks to set-up and staff the exhibit daily. Sara Sheldon, author of <u>The Few. The Proud: Women</u> <u>Marines in Harm's Way</u>, graciously hosted me for the entire event. The response to the WOCC exhibit was huge and has led to the booking of multiple future college and school presentations in Colorado and surrounding states.

### • A Special Day and a Rare and Unique Collection Received by the WOCC

Nancy White Henke enlisted in May of 1943 and was called to active duty in August of 1943. Nancy, a Quaker, grew up in Pennsylvania and attended the Quaker Meetings with her family every Sabbath day. While at one meeting, after listening to numerous young male members stand and give "testimony", stating their decisions to apply their right for Conscience Objector Status and to not serve in the Armed Forces or to bear arms in support the United States, Nancy calmly stood to give her testimony and stated clearly that she would not be at future meetings, as she had taken the oath to be a United States Marine.

[Nancy's story is like that of our first Commandant, Captain Samuel Nicholas, who as a Quaker, lost his standing and membership in the church by choosing to serve our country during the American Revolution. He was reinstated a few years before his death at the age of 54.]

Nancy attended boot camp at Camp Lejeune, followed by training as a truck and vehicle driver. Upon MOS graduation, she was off to MCAF Cherry Point. She viewed the Marine Corps as a way to serve her country in war and also a way to experience the adventure of seeing new places and meeting new people.

Her excellent performance saw her move rapidly to the rank of sergeant. When asked to consider applying for Hawaii duty, Nancy submitted her paperwork and then waited to see if she would be selected. (Being selected for Hawaii duty in WWII was accomplished through a series of multiple Marine and chaplain interviews, a review of the Marine's service record and an official and complete security investigation into the applicant's background.) Nancy's background, training and rapid promotions made her a perfect candidate for Hawaiian duty.

Nancy Henke's albums and memorabilia contain very rare content. Nancy was an amazing artist and her Marine albums contain sketches of the lives of women Marines at each duty station or women units she visited while she was in transit and on assignment in Hawaii. The albums received so far contain perhaps 100 plus clearly identified women Marines filling nearly every page.

This unique collection of photos also contains one of the personal stamps discussed in the October 2014 issue 'Nouncements. These stamps had no monetary value, but in an era where few Marines or individuals owned cameras, these stamps, when attached to letters, allowed families and friends to see them in uniform.

On February 18, 2015, Henke family representatives met with me to open the Nancy White Henke Collection that will be added to in the coming months. During this meeting, each item received was viewed, and its potential future in the WOCC was discussed. We also discussed and made decisions about how the items could be used in the telling and preservation of the history of women Marines.

#### • The Georgine Clontz Collection

WMA member Georgine Clontz has selected a very unique way to save women Marine history. In addition to her personal uniforms, she has expanded the WOCC research library.

Our small library has been part of the WOCC for a number of years and has been used by both WOCC personnel and volunteers for research. It has also been used by graduate students and interns using the WOCC for graduate papers and studies. Georgine, hearing me speak of the library, decided to seek out additional books on women Marines or those containing history on women Marines. When "new finds" of women Marine books became scarce, she expanded her search to books on Marines Corps history as well as other military books of note.

Singlehandedly, Georgine has created a library with data on WWI, Korea and Vietnam that with few exceptions, contains data on the participation of the Marines in our nation's history. Like most libraries, used for research, at some point the new books will need to be reviewed prior to sending or being added to the WOCC. *(Continued)*  Space is just not available to become an all service and war library, nor is it the purpose of the WOCC; but for now, "Georgine's Library" is a unique gift and will continue to be a historically valuable resource.. Thank you, Georgine, for your unique and generous gift.

# Other History Projects Accomplished or in the Works

• Fulfilled multiple requests for photos, uniform history information, and WM history information by a number of chapters in celebration of the recent Women Marine Anniversary celebrations.

• Working with students at a Maryland Prep School, (in the Washington, DC area) on an assigned project that was a result of the December "Women Marine History Presentation" at the NMMC. The project assignment "WWI Marine Opha May Johnson, her life; "marriage, government employee service" and her life as a Marine. The project was expanded to include the life of most women of that era and the influence they had on future generations of women, and then moved on to include the effect all the service women had on the Women's Movement and women's right to vote. Working with

an entire class has been definitely interesting.

• Continuing development of a project for the upcoming 2016 Portland Convention and historical research for 2018 celebration year and Convention. Ongoing personal Collection development.

During her membership, Florence served as former officer for the DC-1 Chapter the National Headquarters Chairperson and in the local Chapters as an Honorary President and Past Vice President and was a Virginia Crossroads Member.

As part of her legacy, Florence asked that her cassette tapes and pictures be forwarded to WMA Historian Nancy Wilt to be donated to WMA National.

On 18 Nov 2014, Caroline (Carrie) Jackson passed. Her daughter, Janice Kingston, informed us that her mother passed after a fight with cancer. Carrie was one of our dear Marine sisters and attended several WMA conventions and even roomed with Florence Leon on one occasion. Carrie was an active Chapter member until her family moved to NC in 2004.

# June Eleanor Harris: A Tribute to the Founder of the Texas Gulf Coast Chapter of Women Marines Association

June Harris, WWII veteran from 1943-1945 and lifetime member #16 of the WMA, was transferred to her final duty station on October 16, 2014 at the ever young age of 93. She passed peacefully into her final sleep with her family and Labrador companion, Shadow, by her bedside in Conroe, Texas. June Brickson was born on June 2, 1921 in Waukesha, WI. She graduated from Carroll College at the University of Wisconsin, where she studied journalism prior to joining the USMCWR in 1943. While stationed at Miramar, she met a Navy Commander from Texas in church and a week later she became Mrs. Edward J. Harris, the judge's wife. In 1945, they were both discharged honorably from their respective branches and returned to June's home state of Wisconsin where Ed got his Law degree. June wasn't idle during this time. She had started a political life of her own and was elected Wisconsin's first woman justice of the peace.

Shortly after Ed got his law degree, they decided to move back to Ed's home state of Texas and June started another form of being a WM as a Wife and Mother of a daughter, Ann, and

son Edward. While in Galveston, June became very active in promoting her husband Ed's political career. She was the voice behind the man and assisted him in getting elected to many offices from city council, to state representative and his last position as state district judge. She was so very proud of Ed and his many accomplishments. She loved politics and being the judge's wife. She was a thrill to be around, with her sig-



nature flower in her curly red hair and that scarlet smile.

June was an active member of WMA from the beginning in June of 1960, when she was contacted by WMA President Ruth Broe about the new organization. She quickly became a lifetime member and during the National WMA Convention in Hawaii, her suggestion of having the next convention in her present hometown of Galveston was approved. The only conflict was that there was no WMA chapter in the Galveston Area.

June, as the National Convention Coordinator for the WMA, was up to the task at hand though, and with the assistance of Captain Beverly Short, the WOSO assigned to the 6th District in New Orleans, the Texas Gulf Coast Chapter was chartered. To commemorate the 31st anniversary of Women Marines on February 9, 1974, 21 of those Women Marines met for a luncheon at the Junior League Tea Room in Houston and organized the local chapter, #45, designated as the Texas Gulf Coast Chapter of the Women Marines Association and June added Chapter President to her many titles. June was a joy to be around and never met an adversary.

She was a friend to all and any willing participants. She was like the Energizer Bunny and was active in numerous clubs and organizations such as Beta Study Club,

Galveston County Kennel Club, Red Cross, Cedar Lawn Garden Club, Galveston County Democratic Party, League of Women Voters, Galveston Art League, Galveston Historical Foundation, By the Sea Condo Residence Association, Moody Methodist Church, and The Marriot Forum of the Woodlands.

Ms. June, as many of us slightly younger in years called her, was my friend and neighbor. After Hurricane Ike hit Galveston, she moved a mile down the road from my residence in Conroe. We instantly

became close and although 50 years apart in age, we were like sisters in the way only Women Marines know how. I loved hearing her tales from when Ed was alive and in politics and she was attending meetings with the First Ladies of the United States. I was just in awe as she talked about teasing Ladybird Johnson about a beautiful pin that the first lady wore, but covered with a collar or scarf as not to appear to be putting on airs. She'd keep you laughing with her blunt honesty and she even kept the pastor of the church we attended together, on the edge of his seat. One of the most amazing things about Ms. June was the way she made others feel important. She was the star of the show, but she gracefully always wanted to share the spotlight. She would tell everyone we'd meet how I was a woman railroad engineer and drove trains and the way she'd talk about it, made me feel like the president of the railroad. It didn't matter what you did in life, she'd make you feel like you were the best and the world would crumble without you!

Ms. June was cremated after her death and a memorial service was held November 15. 2014 in the Chapel at Forest Park of The Woodlands Funeral Home. I arrived early and placed Ms. June's last bumper sticker of the Eagle, Globe and Anchor on the bottom of her urn. There were many friends and family in attendance and not a dry eye in the house, as her granddaughter Mari Jones sung the Lord's Prayer Aria Soprano. It was truly beautiful and Ms. June had good reason to be proud. TX-2 President Judy Anderson read a brief bio on Ms. June's history in the USMC and WMA, and closed with the "Band of Sisters". Pastor Jerry Frank of our local Cornerstone Assembly of God Church officiated the service and then we all went to the atrium where Ed's ashes were already interned for the playing of the "Marines' Hymn" and "Taps'. TX-2 Vice President Karen Beatty presented the flag to Ms. June's grandson Richard Jones, who is also a Marine. Area 6 Director Elizabeth Damron was also in attendance with her 3 year old son, Ryan, to pay her condolences. At the repast, there was a wreath made out of the many flowered hairpins that Ms. June had received at her 90th birthday. We all left with a smile as we remembered the Marine and lady that traded a USMC WM ball Cap for the flower of the season. Semper Fidelis to our departed sister.

# Marian Yancey Landry, 1919-2014 WWII Marine, Musician, Wife, Mother and Beloved Friend

Molly Marine LA-1's eldest member passed away in New Orleans at the age of 95 on 30 December 2014. She was truly an inspiration and will be sorely missed.

Jeanne "Marian" Alva Yancey Landry was born 21 December 1919 to William Paul Yancey and Lydia Cenac Yancey in Davenport, Iowa. Her father was a science and engineering professor at St. Ambrose College in Davenport, IA. Her mother worked most of her life as a nurse anesthetist while rearing three children with the help of her family. Following the untimely death of her father at age 33 in 1925, the family moved to Tampa, FL for two years to reside with their grandmother, Philomena Yancey. This was followed by a permanent move to Louisiana. The trials of the Great Depression helped to forge her character. As a young adult, she worked at the clerk of courts office in Houma, LA and Shell Oil Company in New Orleans, LA.

During WWII, she spent two special years in the Marine Corps Women's Reserve in Washington, DC. She had the somber duty of "pulling the cards" of 50-75 Marine Corps officers who died per day in WWII. She was honorably discharged at the rank of sergeant. She made lifelong friends in the Corps. Later in life, she devoted her time to the Women Marines Association and the Marine Corps League. She enjoyed the loyal company of women currently in the Corps.

On 17 June 1950, she married Claude J. Landry, Sr. at Francis de Sales Catholic Church in Houma, LA. Her uncle Patrick Henry Yancey, SJ officiated. They were married for 48 years. She lived in the same home for 58 years in Lafayette, LA where their three children were born. Her goal during these years was to provide a stable home environment for her family despite life's many challenges. She succeeded. Caring for her family and her home was a labor of love. Once she had more time to herself, she concentrated on her interests and talents. She attended performing arts concerts frequently. She believed in continuing her education. She learned how to play the guitar, how to invest money and run a business. She collected and studied antiques. She refinished antique chairs, teaching herself how to replace cane seats. As a young woman, she played the piano and the accordion. She traveled throughout Europe, North Africa and North America. Her sartorial skills were superior. Cooking remained one of her great loves and talents. Her critical thinking, decision making and organizational skills were frequently on target. She brought excellence to her many endeavors. Her song is done, but the melody lingers.

Marian was a life member of the Women Marines Association and a loyal and motivated member of the LA-1 and TX-2 chapters for numerous years. She remained active until the very end. The last event LA-1 members had the pleasure of sharing with her was at the Chateau de Notre Dame in New Orleans on 20 December to celebrate her 95th birthday and Christmas.

I'll never forget the last two words she whispered in my ear:"Semper Fi". Ten days later, the Supreme Commandant called our beloved Marian home. We are certain that she is standing tall, with many others, guarding the pearly gates. Marian we love you and "Semper Fi"!

If you're married, make sure that you and your spouse understand what financial challenges you face and what benefits you're entitled to. Regularly discussing financial matters can help ensure that both of you are prepared to handle family finances whenever the need arises.

# Five Key Benefits for Military Families

Military families face plenty of financial challenges. If you're saving for college or retirement, buying a home, or wondering how to help secure your family's financial future, don't overlook these five important benefits.

### 1. Thrift Savings Plan

Retirement is something you need to plan for, whether it's far away or just around the corner. Even if you can rely on a military pension because you've stayed in the service for 20 years or more, it's probably not going to provide all the retirement income you'll need, and neither is Social Security. That's why it's important to save for retirement on your own. One option you have is to contribute to the government's Thrift Savings Plan (TSP).

The TSP is a retirement savings plan for federal employees, including servicemembers. When you make traditional contributions to the TSP, you get the same types of savings and tax benefits as you would if you contributed to a 401(k) plan offered by a private-sector employer. Contributing to the TSP is simple--your regular contributions are deducted from your paycheck before taxes (which can lower your taxable income for the year), and your contributions and any earnings accumulate tax deferred until withdrawn in retirement. You can also opt to make after-tax Roth contributions. They won't reduce your current tax liability, but qualified withdrawals in retirement will be tax free (assuming IRS requirements are met).

You can enroll, change, or cancel your contributions whenever you'd like. You can contribute as little as 1% or as much as 100% of your basic pay (or a designated dollar amount) each pay period, up to what's called the elective deferral limit for the year. In 2015, you can contribute up to \$18,000; if you're age 50 or older and are making catch-up contributions, you can contribute up to \$24,000.

If you're contributing a percentage of your basic pay, you can also contribute a percentage of your incentive pay, special pay, or bonus pay (but you can't make catch-up contributions from these types of pay). And if you're deployed and receiving tax-exempt pay (i.e., pay that's subject to the combat zone exclusion), you can also make contributions from that pay, and your contribution limit for the year is even higher; the limit for total contributions from all types of pay is \$53,000 for 2015.

When you leave the military, you can't continue to contribute to the TSP, but you have the option of keeping your money in the TSP or rolling it over to another retirement account, such as a traditional or Roth IRA or an eligible employer plan.

### 2. Savings Deposit Program

Are you trying to save money to buy a vehicle or make a down payment on a home? Do you need to set aside money for a rainy day? If you're deployed to a designated combat zone for at least 30 days, you have a unique chance to save for your goals at a guaranteed interest rate by participating in the Defense Department's Savings Deposit Program (SDP).

The SDP pays you 10% interest on deposits up to \$10,000 while you're deployed, and you'll earn this interest rate on your money for up to 90 days after your return. You may deposit all or part of your unallotted pay. Interest compounds quarterly and is taxable.

Generally, you can withdraw funds and close your account only after you leave the combat zone and are no longer eligible to participate in the SDP, although emergency withdrawals while you're deployed are allowed in some cases.

To find out more or begin participating in the SDP, contact your local military finance office.

### 3. Post-9/11 GI Bill

Education benefits are one of the most valuable benefits available to servicemembers. If you're entitled to benefits, the Post-9/11 GI Bill will pay up to



the full cost of in-state tuition and fees at public colleges for up to four years, or up to a certain maximum per academic year if you attend a private college or foreign school. The maximum for the 2014 academic year (August 1, 2014 through July 31, 2015) is \$20,235.02.

But if you don't need to use your entitlement, the Post-9/11 GI Bill can provide a great way to pay for your family's education. Servicemembers who make a long-term service commitment have the opportunity to transfer unused education benefits (up to 36 months' worth) to their spouses and children.

To transfer your unused benefit entitlement to your spouse, you must have served at least 6 years, and generally commit to serving 4 additional years from the date a benefit transfer is approved (some exceptions to this added service requirement exist). Once the transfer is approved, your spouse may begin using benefits immediately and has 15 years after your last separation from active duty to use up the benefits.

If you opt to transfer your unused entitlement to your dependent children, they can use the benefits only after you've completed at least 10 years of service. In addition, they must have attained a secondary school diploma or equivalency certificate or have reached age 18, and they can use the benefit entitlement only until age 26.

If both your spouse and your children are attending school, you can opt to split your benefit entitlement among them.

#### 4. VA Home Loan

Saving for a down payment is one of the biggest obstacles to homeownership. Fortunately, military families can often benefit from the no-down-payment requirement of a VA loan. This type of loan, which can only be used to finance a primary residence, also features another money saving benefit: borrowers aren't required to pay mortgage insurance.

Despite its name, the VA loan isn't handled by the government. Like other home loans, VA loans are offered by private lenders such as banks, credit unions, and mortgage companies. The VA guarantees a portion of the loan, which may make it easier for you to obtain a loan or qualify for more favorable terms, including lower closing costs and appraisal fees. Not all lenders offer VA loans, so you'll need to ask potential lenders whether they are VA-approved lending institutions.

One lesser known feature of the VA loan program is the opportunity to do a cash-out refinancing. If you have substantial home equity, this feature allows you to refinance an existing home loan (including a non-VA loan) while borrowing extra money, which you can use to pay off debt or make home improvements, for example.

A VA loan is often a good choice for military families, but it's not the only game in town. You should compare the terms, interest rate, closing costs, and fees against other mortgage options. One drawback of a VA loan is the funding fee that's generally required. This funding fee which you pay at closing (it can be financed into the loan) is a percentage of the amount you're borrowing.

#### 5. Servicemembers' Group Life Insurance

Knowing that your family will be protected is extremely important, and affordable term life insurance coverage is available through the Servicemembers' Group Life Insurance (SGLI) program. Eligible servicemembers are automatically enrolled in SGLI, and spouses and dependent children are generally automatically insured through a related program, Family Servicemembers' Group Life Insurance (FSGLI).

When you leave the military, you can apply to convert your policy to Veterans' Group Life Insurance (VGLI), which provides renewable term coverage. An SGLI policy may also be converted to an individual policy sold by a participating commercial company. (Deadlines apply to both types of conversions.) However, you should carefully evaluate your options to determine whether VGLI will meet your life insurance needs. Points to consider include premium costs, plan features, and whether term insurance is your best option.


